RESOLUTION TO PLACE 10% OF FIRE GENERAL BUDGET TO RAINY DAY FUND

Mike Sims made a motion to place the remaining balance of the Fire General Fund in the Rainy-Day Fund. Dave Patty seconded. **Motion passed 3-0**

CLAIM FORMS FOR CONTRCTORS

As another internal control policy, it was decided the Fiscal Officer shall create a claim form for the contractor to fill out for payment of goods and services. Claim form shall include what employee name, purchase date, if the claim is for an apparatus/vehicle or building/landscaping, if the claim is for repair of equipment or new equipment, if approval has been given by 2 board members for expenditures over \$200 and a summary of what the item was used for. Form will be presented at the January meeting for approval and implementation.
