

**ORDINANCE NO. 22-11**

**AN ORDINANCE OF THE CASS COUNTY COMMISSIONERS AMENDING CHAPTER 5, ARTICLE II, SECTIONS 2-70 AND 2-71 OF THE CASS COUNTY CODE AS FOLLOWS:**

**WHEREAS**, the Cass County Commissioners deem it necessary to amend Ordinance 95-02, Chapter 5, Article II, Sections 2-70 and 2-71.

**NOW, THEREFORE, BE IT RESOLVED AND ORDAINED AS FOLLOWS:**

**Section 1.** Chapter 5 Article II, Section 2-70 of the County Code is hereby amended to read as follows:

In accordance with IC 10-4-1-10(d), there is established a Cass County Emergency Management Advisory Council which shall consist of the following members:

- a) The President of the Cass County Commissioners or his/her designee;
- b) The President of Cass County Council or his/her designee;
- c) The Mayor of the City of Logansport or his/her designee;
- d) A representative of either the Logansport Police or Fire Departments, as appointed by the Mayor;
- e) An individual representing the legislative bodies of all towns located within Cass County;
  - a. Town of Galveston
  - b. Town of Onward
  - c. Town of Royal Center
  - d. Town of Walton
- f) An individual of the Cass County Sheriff's Department as recommended by the Sheriff, Cass County, Indiana;
- g) An individual being a member of the Cass County Emergency Ambulance Service to be recommended by the Cass County Emergency Medical Services Board;
- h) An individual to be appointed representing the Cass County Fire Departments (north half of county), to be selected by the County Commissioners;
- i) An individual to be appointed representing the Cass County Fire Departments (south half of county), to be selected by the County Commissioners;
- j) An individual to be appointed representing public works (i.e. Utilities, highway), to be selected by the County Commissioners;
- k) A representative of or liaison to the Civil Air Patrol;

The Advisory Council shall have a Chairman, Vice Chairman and Secretary.

**Section II.** Chapter 5, Article II, Section 2-71 of the Cass County Code is hereby amended to read as follows:

THE TERMS of the members of the Cass County Emergency Management Advisory Council shall be as follows:


- a) One Year Term:


- 1) The individual representing the legislative bodies of all towns located within Cass County;
  - 2) Cass County Sheriff's Department member;
  - 3) Cass County Emergency Medical Services member;
- b) Two Year Term:
- 1) Cass County Fire Service Representative
  - 2) Cass County Public Works Representative
- c) The Cass County Council, Cass County Commissioners and the Mayor of the City of Logansport, or their respective designees' term shall be permanent unless otherwise revised by State Statute and/or county ordinance. Said designee(s) shall serve at the pleasure of the respective office holder.


ALL PRIOR ORDINANCE or parts thereof inconsistent with any provision of this Ordinance are hereby repealed.

**Section III. THIS ORDINANCE IS HEREBY PASSED AND ADOPTED**, at the regular meeting of the Cass County Commissioners of Cass County, Indiana, the 3rd day of October, 2022.
