C. State Fire Marshal Report - Stephen Jones

- NFSA Sprinkler Training Trailer demonstrations over three (3) days at Indiana University, Notre Dame University, and Purdue University with approximately 400 attendees.
- 2. Evansville house explosion investigation complete. Explosion was due to an uncapped gas line in the basement.
- 3. Evansville warehouse fire that burned for several days with no injuries reported to firefighters or the public.
- Laporte County had a large warehouse fire that surrounded the town's water tower.
- Conducted a meet and greet with the LaGrange Amish Volunteer Fire Department.
- 6. Several recent suicides by fire.
- 7. Arson Investigators have done 562 investigations thus far this year.
- 8. EMS recruitment efforts continue.

D. Academy and Operations Report – Elizabeth Westfall

- 1. Regine Johnson is no longer with IDHS and the Fire Academy. Please contact Nichelle Elliott with any certification questions. Program Managers are assisting with processing of certifications.
- 2. Groundbreaking of new Fire Training Facility at Fire Chief Alan W. Burns Advanced Firefighter Training Facility in Plainfield is scheduled for December 8, 2022, at 11 a.m. Eastern Standard Time. All Firefighter Board members are invited to attend and will receive a formal invitation.
- 3. The Academy has awarded \$360,593.74 in local training and structure grants to 49 entities since 2021.
- 4. Issued firefighter certifications have increased since 2021. In 2021, the Academy issued 11,264 certifications; and thus far in 2022, the Academy has issued 12,768 new firefighter certifications.
