LEPC Newsletter

Ms. Chaney stated PIO staff asked for a generic email box and telephone number for the publication. Mr. Larmore asked if

they could use the cover photograph since staff had been advised not to use explicit pictures such as an explosion on a public document. Ms. Chaney reported the newsletter is solely for the LEPCs so the picture can be used and it is an IDHS owned picture from an actual incident. She explained that the LEPCs can subscribe to the newsletter like other state publications. Mr. Larmore stated this was a great start and was happy this was for LEPCs, so they had the choice to share it. Ms. Waymire requested that the listed conference name be changed to EMAI/ IERC conference. Ms. McKinney agreed since it was a partnership between the EMAI and the IERC. Mr. Larmore asked when the newsletter would go out. Ms. Chaney and Ms. Mason stated they'd like it to go out in January and August annually to serve as a reminder.

EMAI/IERC Conference Speakers & Planning

Ms. McKinney shared the agenda with the committee. She stated Ms. Chaney and Mr. Ewusi contributed speakers and tittles to the agenda applauded the content contribution from the IERC to add. The committee discussed the IERC suggesting and adding speakers. Ms. Chaney mentioned they could pull speakers from real world hazmat incidents to increase the amount of hazmat content.

Request for Funding EMAI/IERC Conference

Mr. Larmore stated in past years the IERC has voted on a grant of \$10,000 to EMAI for the conference. Mr. Ewusi said during the last IERC meeting EMAI representatives explained how the money was used to which the commission found to be satisfactory. Ms. Chaney noted that the representatives agreed to better budget the 2019 EMAI/ IERC conference to account for how that money was spent. Mr. Ewusi went on to state the IERC agreed to submit more hazmat content to the conference. The committee agreed to discuss the 2020 EMAI/ IERC grant stipulations. Mr.

Kinney stated he did not believe the commission has ever requested a formal budget from the EMAI. Mr. Larmore stated they want the conference to have more hazmat materials content. Ms. Waymire strongly agreed with this statement and asked for more LEPC specific content. Ms. McKinney addressed the confusion about the commission registration by stating the grant paid for the commission and committee member registration.
