



## BOARD MEETING MINUTES

- 1. This meeting of the Indiana Secured School Safety Board was opened by Chairman Langley at 3:00 p.m. on Wednesday, August 14, 2019:

2. Roll Call

Rusty Goodpaster conducted roll call, and determined quorum was present.

3. Approval of June 11, 2019 Meeting Minutes

Kevin McDowell abstained, as he was not in attendance at the previous meeting. Doug Carter moved to approve the June 11, 2019 meeting minutes. Devon McDonald made the second. Roll call was conducted: Doug Carter, Kenneth Folks, Bryan Langley, and Devon McDonald all voted yes. The motion was approved.

- 4. Advance from Common School Fund Application
  - a. West Lafayette Community School Corporation: The applicant requested \$100,000 from the Common School Fund for a warning system. The request was received on July 16, 2019. The vendor is off of the Sheriff's Association's list. The applicant also asked for \$80,000 from the SSSG fund for a warning system; they asked for \$20,000 from the SSSG fund for an SRO. Rusty Goodpaster recommended approval with the stipulation that the Common School Fund request may be amended upon approval of SSSG funding. Devon McDonald moved to approve with the stipulation that this request may be amended upon approval of SSSG funding. Doug Carter made the second. Roll call was conducted: Doug Carter, Kenneth Folks, Bryan Langley, Devon McDonald, and Kevin McDowell all voted yes. The motion was approved.
  - b. Options Charter School Carmel: This request was not received until August 2, 2019, so the 30 days is not up yet. Rusty Goodpaster explained that he was not sure whether the applicant realized that this money is from IDOE instead of IDHS. He has been unable to contact the applicant, but will continue to try to reach them in order to gather more details about their request. No action taken.
- 5. SSSG Update

A total of 429 applications were submitted. IDHS Staff is currently analyzing data in order to make funding determinations, which will be presented at next week's meeting. Applicants were asked to prioritize funding which should be helpful.
