	Project provided adequate connection to core capability.	3 points
	Project provided multiple detailed and specific connections to the chosen Core capability.	5 points
Are the items allowable?	Non-allowable items	0 points
	Some items are allowable, some not	3 points

How well does the applicant tie their project to terrorism?	Does not mention terrorism.	0 points
	Rarely mentions terrorism and there is no clear tie to the project.	1 point
	Rare mention of terrorism with a weak tie to project.	2 points

	Good amount of mentions of terrorism and good tie to the project.	4 points
	Provided multiple detailed and specific mentions of terrorism that directly tie into the project.	5 points
How well does the project include collaboration with mentioned entities?	Applicant does not mention any collaboration.	0 points
	Applicant mentions minimal collaborative efforts in their project.	1 point
	Applicant mentions adequate collaborative efforts in their project.	3 points
	Applicant mentions multiple distinct collaborative efforts in the project.	5 points

Is the applicant a part of an underserved community?	Applicant is not a part of an underserved community.	0 points
	Applicant is a part of an underserved community but gave minimal explanation.	3 points

Is the problem significant enough to warrant funding?	Does not warrant funding, no connection to scope of the grant.	0 points
	Has minimal connection to scope of grant.	1 point
	Has a connection to grant, but it is weak.	2 points
	Has an adequate connection to scope but doesn't go above and beyond in application detail.	3 points
	Has a good connection to the scope of the grant.	4 points
	Goes above and beyond in the scope of the grant and goes in depth about the connection between the project and scope.	5 points
