Seifert expects LSR grants program to be similar to last year and encouraged partners to begin developing proposals immediately. He encouraged members to lean heavily on very detailed and informative website (referenced in presentation) that shows all past proposals and rankings and is a wealth of other information. Also, he encouraged partners to work closely with DoF and USFS staff to ensure that you are properly prepared to submit a proposal with DUNS #, correct budget forms, etc. He stressed that the work be done early and the earlier the better. He suggested that a good dialogue with State and Federal offices and a proposal with nice letters of support all lined up in mid-Summer would go a long way toward ensuring success. Seifert reminded participants that proposals must be linked with Indiana's Forest Action Plan and the Division of Forestry is happy to provide feedback and advice for partners interested in submitting proposals but cautioned that the heavy lifting of writing the proposal and submitting the required paperwork will need to be completed by the outside organization.
