SETTLEMENT AGREEMENT

The Commissioner of Labor (hereinafter referred to as "Commissioner") and Roadrunner Transportation Services, Inc. (hereinafter referred to as "Employer" or "ER") hereby agree as follows:

The Commissioner amends the Safety Order(s) and Notification(s) of Penalty IOSHA Inspection No. 318104668 issued to the Employer on February 4, 2019 in the following manner:

SAFETY ORDER 01:

Item 1: Upheld. Penalty is reduced to \$3500. Abatement completed.

The Alleged Violation Description is amended to the following:

Dock #60 - On October 25, 2018 and at time prior to, operators of forklifts such as, but not limited to; a Nissan Uni-Carriers MCP1F2A252LV, did not wear seatbelts but fastened them in a manner to bypass the safety switch which allowed power to remain at the controls when not in the seat. However, this item citation does not directly relate to the accident that is the subject of the inspection.

AMONG OTHER METHODS, FEASIBLE MEANS OF ABATEMENT MAY INCLUDE: Follow the ANSI/ITSDF B56.1 - 2009 SAFETY STANDARD FOR LOW LIFT AND HIGH LIFT TRUCKS, 5.3.19 which states "An active operator protection device or system, when provided, shall be used. Operator protection in the event of a tip over is intended to reduce the risk of entrapment of the head and torso between the truck and the ground but may not protect the operator against all possible injury (see para.7.2.2)."

Item 2: Dismissed. Penalty is reduced to Zero Dollars (\$0).

Item 3 Reduced to Nonserious. Penalty remains \$3500. Abatement due dates are set forth below.

In consideration of the above amendments, the Employer:

- 1. Employer implemented a supplement to their forklift safety policy which includes keeping *all* body parts inside the forklift.
- 2. Employer trained all employees on the supplement to their current forklift safety policy.
- 3. Employer provided signed EE acknowledgments of supplemental forklift training.
- 4. Employer agrees to guard the mast area from employees by March 6, 2020.
- 5. Employer implemented the training on keeping body parts inside the forklift cab as an interim measure to paragraph #4.
- 6. Employer agrees to place stickers/labels on the masts or in all the forklifts that states for the operator to keep *all* body parts inside the operator cab or running lines of the forklift by June 9, 2019.
- 7. Employer agrees to conduct hands-on training of the supplement to the forklift training regarding keeping *all* body parts in the forklift by June 9, 2019 as another additional interim measure for item #4.
- 8. Employer agrees to submit all abatement documentary, photo evidence and training records to the electronic mail inbox, AbatementGI@DOL.IN.GOV, on or before the due dates specified in this agreement.

The TOTAL AGREED PENALTY is \$7000.

THE EMPLOYER IS SATISFIED WITH THE AMENDMENTS STATED ABOVE AND ACCORDINGLY WAIVES ITS RIGHT TO FILE A NOTICE OF CONTEST OF THE SAFETY ORDER(S) AND NOTIFICATION(S) OF PENALTY AS AMENDED AND AGREES TO WITHDRAW ANY PREVIOUSLY FILED NOTICES OF CONTEST IN THIS MATTER.

Upon full execution of this Settlement Agreement ("Agreement") the Employer will post this Agreement for three (3) working days or until abatement is completed, whichever period is longer.

The Safety Order(s) and Notification(s) of Penalty are, and shall be, herein a final and enforceable Order of the Board of Safety Review.

The total AGREED PENALTY is due and payable within fifteen (15) working days from the Employer's execution of this Agreement. The Employer further agrees that if the AGREED PENALTY is not paid within fifteen working days from the Employer's execution of this Agreement, that the full amount of the penalty initially assessed against the Employer in the Safety Order(s) and Notification(s) of Penalty which are the subject of this Agreement is due and payable immediately.

Except for this Agreement, and IOSHA matters arising out of this Agreement, and any other subsequent IOSHA proceedings between the parties, none of the foregoing agreements, statements, findings, and actions taken by Employer shall be deemed an admission by Employer of the allegations contained within the Safety Order(s) and Notification(s) of Penalty. The agreements, statements, findings and actions taken herein are made in order to compromise and settle this IOSHA matter economically and amicably, and they shall not be used for any other purpose, except as herein stated.

On alleged violations with abatement periods of more than thirty (30) days, a written progress report should be submitted via email at <u>AbatementGI@dol.in.gov</u>, detailing what has been done, what remains to be done, and the time needed to fully abate each such violation. When the alleged violation is fully abated, we should be so advised. Timely correction of an alleged violation does not affect the initial proposed penalty..

Followup Inspections - Please be advised that a followup inspection may be made for the purpose of ascertaining that you have posted the safety order(s) and corrected the alleged violations. Failure to correct an alleged violation may result in additional penalties for each day that the violation has not been corrected.
