To The Honorable Mayor Seybold and the Dislocated Worker Unit:

On June 19, 2012, Aramark Business Facilities, LLC was informed that it would not be retained to provide facility maintenance, janitorial and skill trades services at General Motors at 2400 W. 2nd St., Marion, Indiana 46952. As a result and to the best of our knowledge, ARAMARK will permanently close its operations at General Motors on or around August 1, 2012 and permanently terminate the employment of its employees assigned to duty at such facility on such date.

The closing of this account was an unforeseen business circumstance as ARAMARK had no prior indication that the client would be terminating the contract so abruptly. ARAMARK has provided notice as soon as possible given these unforeseen circumstances.

Additionally, the employees at this account may be offered employment by the subsequent contractor; however, there are no guarantees of continued employment that we are aware of.

Accordingly, we are sending you this notice to satisfy the requirements of the Federal Worker Adjustment and Retraining Notification ("WARN") Act, 29 U.S.C. § 2101 et seq. While we have not determined that WARN is applicable to this closing, we are providing this notice in the event that WARN is deemed to apply. WARN requires that we notify you of the following:

1. As a result of the closing described above, ARAMARK expects to permanently terminate its employees at General Motors in Marion Indiana.
2. The specific job titles of our employees affected by this facility closing, as well as the number of our employees in each job classification, are listed on the attachment to this notice.
3. There are no bumping rights applicable to these employees.
4. The name of each union representing our employees affected by this facility closing and the name and address of the chief elected officer of each union is as follows:
