Dear Mayor Hogsett and Indiana Department of Workforce Development:

On January 4, 2023 Gannett Publishing Services in Indianapolis notified production employees at its Indianapolis Star property that it has decided to permanently partially close the production operation, by reducing its regular operation of four (4) presses to two (2) presses, at its facility located at 8278 Georgetown Road, Indianapolis, IN 46268.

This notice, which is issued in compliance with the Worker Adjustment and Retraining Notification (WARN) Act, 29 U.S.C. § 2101, *et seq.*, is to inform you that certain of the production employees working at that location will be affected by the closing of the production operation. The Company expects layoffs to begin at or about March 13, 2023 (or on a date within the 13-day period immediately following March 13, 2023). There is not any contractual bumping rights system that exists for union employees, and there is also no bumping rights system for non-union employees. The final shift for impacted employees is also anticipated to be on or about March 13, 2023 (or on a date within the 13-day period immediately following March 13, 2023).
