To Whom It May Concern:

This notice is being provided pursuant to the Worker Adjustment and Retraining Notification (WARN) Act of 1988, which requires employers to provide notice to certain government units or officials of a pending

mass layoff or permanent closure.

This is to advise you that between April 25, 2021 and May 7, 2021, Performant Recovery, Inc. reasonably expects to conduct a layoff affecting up to 75 currently active employees based out of our office located at 2002 Wellesley Blvd. #100, Indianapolis, IN 46219, that would permanently reduce the number of employees in applicable positions in that location. A list of the positions held by these currently active employees is attached as Exhibit A.

In addition, and in the interest of completeness, we call to your attention that 40 employees were previously placed on temporary furlough from this same location, pending the possibility of recall. Although these employees are on "inactive" status, we are nevertheless notifying them of formal layoff at this time. A list of the positions held by these inactive employees is attached as Exhibit B.

Numerous changes brought about by the COVID-19 global pandemic, together with recent government decisions regarding federal student loan processing, have significantly impacted our recovery business, resulting in these employment changes. While-we are actively exploring strategic options that may provide continued work opportunities for some employees, we cannot guarantee that these opportunities will materialize.
