Dear CCDF Program,

We are writing to you today to share some detailed information about the Child Care Development Fund (CCDF) rule changes that will go into effect October 1, 2018. In the original letter sent to you by the Office of Early Childhood and Out of School Learning (OECOSL) on April 7, 2018 there were seven areas where federal rules were changed:

- 1. CCDF Eligibility (Shared June 18, 2018)
- 2, Legally Licensed Exempt Providers Certificate (LLEP) (Shared June 18, 2018)
- 3, Background Checks and Challenge Process (Shared June 18, 2018)
- 4, Consumer Statement (Shared July 17, 2018)
- 5, Consumer Education (Shared July 17, 2018)
- 6. Complaint Hotline (Shared July 17, 2018)
- 7. Suspension and Expulsion

This letter provides detailed information about the last area that is balded above: **Suspension and Expulsion**, If you have any questions about these changes please contact Brighter Futures Call Center at 1-800-299-1627.

## **Suspension and Expulsion:**

In order to promote positive social and emotional growth in all early education environments, the lule includes requirements for the State of Indiana and child care programs that are eligible to accept CCDF vouchers to have a policy regarding suspension and expulsion.

- All early childhood programs that are eligible to accept Child Care Development Fund (CCDF) vouchers
  are required to have a policy on suspension and expulsion. The policy must be clearly communicated to
  families before enrollment. The OECOSL will expect a procedure to be created to inform existing families
  of the new policy,
- The policy must promote positive social and emotional growth and should include age appropriate positive behavior suppmis. It should limit or eliminate altogether the use of expulsion, suspension, and other disciplinary practices that center on excluding children.
- A child cannot be expelled, due to behavioral challenges, unless the procedures outlined in the suspension
  and expulsion policy have been followed, The suspension and expulsion policy must clearly define the
  steps that must be followed when a child engages in challenging behaviors that cannot be resolved using
  ordinary classroom strategies.
- Suspension and expulsion due to non-payment is a separate issue and <u>not</u> a part of this rule,
- The Suspension and Exclusion policy will be monitored by your consultant when completing a regulatory visit. This policy will be required to be created and available for monitoring purposes by your next annual visit following October 1, 2018,
