Ethics Requirements for Special State Appointees:

- Required to complete Ethics training within six (6) weeks of appointment to a board or commission and a refresher training every two (2) years.
- Ind. Administrative Code 42 IAC 1-4-1



Special State Appointees Defined:

- Includes a person elected or appointed to board, commission, committee, or counsel authorized by statute or executive order and functioning in a policy or advisory role in the executive branch of government
- Ind. Code 4-2-6-1



Medicaid Advisory Committee Role:

- MAC is established by statute: Ind. Code 12-15-33-2
- The MAC acts in an advisory capacity for the administration of the Medicaid program



Ethics Training and Refresher Requirements:

- Training is done through the Office of the Inspector General website

Main Ethics Topics for Special State Appointees to be Aware of:

Political activity (42 IAC 1-5-4): cannot engage in political activity, including fundraising, while on duty or in your official capacity as special state appointee



Main Ethics Topics for Special State Appointees (cont.):

Conflicts of Interest-Contracts (Ind. Code 4-2-6-10.5): cannot have a financial interest in a contract with any state agency. If a financial interest exists, must ensure compliance with certain requirements before the contract is executed



Main Ethics Topics for Special State Appointees (cont.):

Conflicts of Interest-Decisions and Voting (Ind. Code 4-2-6-9): cannot participate in decisions or votes, or anything relating to decisions or votes if you or certain other individuals have a financial interest in the issue
