


## Community Connections

## SPEAKERS

### Richard Jackson, M.D., M.P.H.

**Professor, Institute of the Environment & Sustainability at UCLA School of Public Health; Urban Planning at UCLA Luskin School of Public Affairs**

Dr. Richard Jackson has done extensive work on the impact of the environment on health. Over the past decade, much of his work has focused on the 'built environment' and how architecture and urban planning affects health. Dr. Jackson is developing policy analyses on how farm, education, housing and transportation policies affect health. He has co-authored two books, *Urban Sprawl and Public Health* and *Making Healthy Places*, and recently hosted a four-part PBS television special on *Designing Healthy Communities*. Dr. Jackson has also served on many environmental and health boards, as well as on the Board of Directors of the American Institute of Architects.

### Antonio Riley

**Regional Administrator for Midwestern Region, U.S. Department of Housing and Urban Development (HUD)**

Antonio Riley serves as HUD's liaison to mayors, city managers, elected representatives, state and local officials, congressional delegations, stakeholders and customers. He is responsible for overseeing the delivery of HUD programs and services to communities, as well as evaluating their efficiency and effectiveness. Riley is one of only 10 Regional Administrators in the nation, serving on the Board of Directors of the National Council of State Housing Authorities. He has also worked with the Wisconsin Housing and Economic Development Authority (WHEDA) and Milwaukee's Department of City Development.

### Fred Kent

**Founder and President, Project for Public Spaces**

Fred Kent is a leading authority on revitalizing city spaces and one of the foremost thinkers in livability, smart growth and the future of our cities. He is known throughout the world for his dynamic speaking and prolific ideas. Traveling more than 150,000 miles each year, Kent offers technical assistance to communities and trains 10,000 people in "place-making" techniques. He worked with William H. Whyte on the Street Life Project, which resulted in the publication of *The Social Life of Small Urban Spaces*. Previously, Kent served as program director for the Mayor's Council on the Environment in New York City under Mayor John Lindsay, as well as the coordinator and chairman of New York City's Earth Day.
