Background

The Association of State and Territorial Dental Directors (ASTDD) and the Council of State and Territorial Epidemiologists (CSTE) have recently provided guidelines for what they consider the minimal requirements for a surveillance system related to oral health for each state.

Current Report

This Oral Health Program (OHP) at the Indiana State Department of Health has prepared an initial report, the *Indiana Oral Health Surveillance Report – 2016*, that provides information that fulfills these requirements. The OHP has also selected this information because it is readily available and is updated on a regular basis by the entities that collect the associated data.

The report is organized so that various oral health metrics are categorized by age group. Some of these metrics indicate the *oral health status* of a certain cohort, while other metrics indicate the proportion of a cohort that has *visited a dentist* or has received a *preventive intervention*.

The last three items in the report refer to oral health-related documents that the OHP periodically produces, which provide information about current and further activities of the OHP, as well as general oral health information for the public.

As the oral health metrics are reported over time, it will be possible to examine trends in oral health in Indiana, which may be useful for various stakeholders when they consider how oral health activities and policies in the state might impact the overall oral health of the residents of Indiana.
