### I. Call to Order

Chairman Borst called the meeting to order at approximately 10:36 a.m. A quorum was present.

## II. Approval of the meeting memorandum and executive session memorandum from the March 21<sup>st</sup>, 2023, Commission meeting.

### III. Agenda

1. Presentation by VICI regarding calling of option.

Mr. Rothenberg introduced Mr. Sebastian Smelko of Ice Miller, representing VICI. Mr. Smelko presented a short overview introduction to the VICI call option and what VICI anticipated would be the result of the option. John Payne of VICI presented a history of VICI and its position in the REIT market today. David Kieske explained a triple net lease. Samantha Gallagher presented a history for the call option itself and how it came to be. Elena Keil outlined the effects of the purchase by VICI. Chairman Borst, Commissioner Levengood, and Commissioner McCarty commented on the presentation and asked brief questions, stating that there would be follow-up questions in the future.

Roger Young commented from the audience stating that it is not possible yet to comment on the merits of the proposal yet, since the details are not known. He did state, however, that on behalf of the Indiana Standardbred Association, they feel that the standard for approving the purchase is a high bar.

Brian Elmore introduced Joe Davis, president of the HBPA, Katy Duran, first vicepresident of the HBPA, and Jeffrey Stemerick, attorney at Taft Stettinius, representing the HBPA. Mr. Elmore stated that the HBPA is opposed to any REIT operating racetracks.

Tony Renz stated that the Indiana Standardbred Association is opposed to any REIT coming into Indiana equine whatsoever.

Dwayne Rhule commented that this is a complex issue, and he looks forward to commenting in the future.

2. Consideration of the Settlement Agreement between the Indiana Horse Racing Commission Staff and Thomas Amoss.

Mr. Pennycuff introduced the Agreement which resulted in a 15-day suspension, a 45-day deferral, and a fine of \$5,000.

Chairman Borst asked the Commission if there was a motion and a second regarding approval of the Settlement Agreement. Commissioner McCarty moved to entertain the motion. Commissioner Estes seconded. Chairman Borst then asked if there were any questions. With no response, Commissioner Borst requested a vote. 3. Consideration of the Administrative Law Judge's Recommended Order in the matter of Dr. Cynthia Loomis v. IHRC Staff, Administrative Cause No. HRC-2211-002419.

Mr. Eggiman introduced the ruling which resulted in a suspension of 60 days and a \$5,000 fine.

Chairman Borst asked the Commission if there was a motion and a second regarding adoption of the ruling. Commissioner Pillow moved to entertain the motion. Commissioner Estes seconded. Chairman Borst then asked if there were any questions. With no response, Commissioner Borst requested a vote. 4. Consideration of the Administrative Law Judge's Order Dismissing the matter of Dr. Cynthia Loomis v. IHRC Staff, Administrative Cause No. HRC-2301-000115.

Mr. Eggiman introduced the ruling which resulted in no penalty.

Chairman Borst asked the Commission if there was a motion and a second regarding adoption of the ruling. Commissioner Estes moved to entertain the motion. Commissioner Pillow seconded. Chairman Borst then asked if there were any questions. With no response, Commissioner Borst requested a vote. 5. Ratification of Executive Director's Interim Approval of Pointsbet's ADW Racing Application and Website.

Mr. Pennycuff outlined Pointbet's plan which includes to add changes to their new website, PointsBet.com.

Chairman Borst asked the Commission if there was a motion and a second regarding approval of this material change to the PointBets ADW application and website. Commissioner Estes moved to entertain the motion. Commissioner McCarty seconded. Chairman Borst then asked if there were any questions. With no response, Commissioner Borst requested a vote. 6. Ratification of Executive Director's Approval of Horseshoe Indianapolis Additional Capital Substitution Request.

Eric Halstrom presented the need for a new gator which Horseshoe is asking to be allowed to purchase in lieu of a new drone, after not finding a drone that meets their satisfaction.

Chairman Borst asked the Commission if there was a motion and a second regarding ratification of the Executive Director's approval of this purchase. Commissioner

7. Ratification of Executive Director's Approval of Hoosier Park Additional Funding request for apron upgrade.

Rick Moore highlighted improvements that will be made to the apron area at Hoosier Park. Mr. Moore emphasized that this was a collaborative project, working with Tony Renz and John DeLong from the ISA. The area will be turned into a park with many accommodations for the public.

Mr. Renz outlined the details and the excitement at the track of the horsemen and the casino. Commissioner McCarty inquired on the timetable for completion and Mr. Moore stated their goal was August 11<sup>th</sup>. The total price will be approximately \$372,000.

Chairman Borst asked the Commission if there was a motion and a second regarding ratification of the Executive Director's approval of this apron upgrade. Commissioner Levengood moved to entertain the motion. Commissioner Pillow seconded. Chairman Borst then asked if there were any questions. With no response, Commissioner Borst requested a vote. 8. Consideration and approval for purchase from RCFAC funds to update Harrah's Hoosier Park AV Broadcast Production Switcher fro on-air simulcast shows and productions.

Mr. Moore outlined the need to replace this outdated equipment. Commissioner Levengood stated that he is very familiar with this type of equipment and noted that the track needs to make sure the new equipment is compatible with the present cameras.

Chairman Borst asked the Commission if there was a motion and a second regarding the approval of this purchase. Commissioner McCarty moved to entertain the motion. Commissioner Estes seconded. Chairman Borst then asked if there were any questions. With no response, Commissioner Borst requested a vote. 10. HISA/HIWU Voluntary Agreement Status Update with a report from Commission Equine Medical Director, Dr. Kerry Peterson regarding the implementation of the anti-doping program.

Mr. Eggiman set the stage for Dr. Kerry Peterson's presentation by giving a general overview of HISA/HIWU and how the process has brought the commission to where it is in regard to that agreement.

Dr. Peterson presented the current procedures and metrics that have resulted from operating under HISA/HIWU so far this year. Dr. Peterson highlighted test barn operations and adjustments that have had to be made to streamline processes. In response to a training question from Commissioner Levengood, Dr. Peterson stated that there is ongoing virtual training online after which a trainee receives a virtual certificate of completion.

Senor Steward Eric Smith explained the process of how "specials" are selected for testing and the requirements under HIWU.

Commissioner McCarty had questions concerning financing which were fielded by Executive Director Pitman and Mr. Eggiman.

13. Seasonal race meet updates from tracks.

Mr. Moore stated that everything is going well regarding handles at Hoosier Park. Additionally, Mr. Moore thanked Mr. DeLong and Mr. Renz as well as Jessica Barnes for working together and making this season's start a great one.

Eric Halstrom stated that their handle is up 42 percent over last year at this time, last year being a record setting year. Both thoroughbreds and quarter horse starters are up this year, by 7.9 and 9.4 respectively. Mr. Halstrom also reminded everyone that the Indiana Derby is on July 8<sup>th</sup>. Commissioner Levengood asked if the track records physical public attendance. Mr. Halstrom responded that no, they do not, but he feels that track attendance is up.

There was no other new business.
