


# INDIANA LATINO POPULATION

## The last 20+ years have seen a dramatic increase in the population of Hispanic persons in Central Indiana.

The age distribution of central Indiana's Hispanic population differs notably from that of the overall population. As seen below, the region's Hispanic population is substantially younger: just over half are 24 or younger, compared to about one-third of all residents. Conversely, nearly 38 percent of all residents are at least 45 years old, vs. only 15 percent of the region's Hispanics.




More than 70% of the central Indiana Hispanic/Latino residents claimed origins in Mexico, with Central America placing second at 13%.

# INDIANA LATINO POPULATION

Spanish is central Indiana Hispanics' most common language spoken at home, spoken by more than 73% of the group. English was also spoken at home (with various self-rated levels of proficiency) by 68 % of Hispanic residents, though only 26 percent spoke exclusively English at home.





**Indiana Education** 

In 2016, 52% of Hispanic students enrolled in college compared to 57% of Black students and 66% of White students.

As Hispanic students continue to make up a larger portion of the higher education pipeline, more efforts are needed to increase college access rates for these students.

#### **Indiana Education**

Between 2011 and 2016, the college going rate for Hispanic students increased at two to three times the rate of White Students. During the same time period, Black students experienced a five percentage point decline in college going.

If these trends continue, Black and Hispanic students will be roughly 20% less likely than their White peers to go directly to college after high school graduation.

Extended Graduation Rate: Extended graduation rates continue to rise for all student populations

-59% of Hoosier students graduate college within the extended timeframe of six years.

-When the data is disaggregated by race/ethnicity, Asian students are most likely to complete college within theextended timeframe (73%), while Black students are the least likely (34%).

-Over the past five years, extended graduation rates rose the most for the Other and Hispanic populations.



#### **Indiana Education**

Between fall 2008 and fall 2013, on-time completion rates for Hispanic students at four-year institutions increased by 12 percentage points.

#### What's going on?

During 2010-2014, 57% of pregnant Latino women initiated prenatal care during the first trimester of pregnancy- one of the lowest rates among other population groups in Indiana. However, during the same time period, Indiana Latinos had the lowest rate of low birth weight babies- 65.4 per 1,000 live births. The teen birth rate for Latino females aged 19 years and younger was 118.3 per 1,000 live births in 2010-2014. This is much higher than White and Asian teens.





Smoking is a significant risk factor for cancer, heart disease and stroke, the leading causes of death among

Latinos. Lung cancer is the leading cause of cancer deaths among Latinos, with lung cancer deaths about

three times higher for Latino men than for Latino women.

### The smoking rate for Latinos in Indiana (16.8%) is higher than the U.S. average for Latinos of 14.8%.



#### **Latino Youth Smoking Rates:**

• Smoking rates among middle school youth do not vary widely between African American students (4.7%) and White students (4.1%), however Latino middle school students smoke at a substantially higher rate of approximately 8.8%.

• Latino high school students have a higher smoking rate than African American high school students - 21.0% of Latino youth smoke while 9.2% African American high school youth report smoking.

#### Indiana Latinos' Attitudes and Beliefs about smoke-free air policy

 $\cdot$  The majority of Latinos in Indiana (92%) believe smoking should not be allowed in the workplace.

• Latinos (70.9%) are more likely to believe that exposure to secondhand smoke is a serious health hazard that Whites (56.2%)

• Latinos are more likely to agree that secondhand smoke is a cause of Sudden Infant Death Syndrome (SIDS) and lung cancer than Whites.

#### Indiana Latinos' Attitudes and Beliefs about smoke-free air policy

• 4.8% of Latino people in Indiana have been told they have diabetes by a doctor compared to 11.4% of all adults in Indiana.

• Latino males in Indiana are more likely to be told they have diabetes than Latina females.

5th Diabetes is the 5th leading cause of death for Latinos in Indiana.

# INDIANA CIVIL RIGHTS COMMISSION STATISTICS


The Indiana Civil Rights Commission (ICRC) is responsible for enforcing the antidiscrimination laws of the Indiana Civil Rights Law (IC 22-9) and the Indiana Fair Housing Act (IC 22-9.5) Its a jurisdiction covers individuals, private or public entities, housing providers and business establishments within the State of Indiana whenever there is a belief that a member of a protected class has been discriminated against.

#### What is Discrimination?


The practice of denying equal rights to a properly qualified person by reason of the person's protected characteristics is contrary to the principles of freedom and equality of opportunity. Such acts are burden to the objectives of the public policy and shall be considered as a discriminatory practices.

ICHLA and ICRC are working in collaboration to protect civil rights, eliminate discrimination and increase equal opportunities for Hispanics and Latinos in the state of Indiana.

Many events celebrating the Latino and Hispanic culture and Latino leaders were held through the state during National Hispanic Heritage Month. In September of 1968, Congress authorized President Lyndon B. Johnson to proclaim National Hispanic Heritage Week. In 1989, Congress expanded the observance to a month long celebration September 16 to October 15, of culture and traditions of those who trace their roots to Spain, Mexico and Spanishspeaking nations of Central America, South America and the Caribbean.

They learned how culturally responsive recruitment and retention methods are vital to degree completion for our Latino students. This event provide the 2018 College Equity Report by the Indiana Latino Higher Education Consortium in order to understand and create awareness on strategies involving higher education access and success.





#### **Indiana Latino Education Summit**

The Indiana Latino Institute hosted the 5th Annual Indiana Latino Education Summit in 2018! This event provided over 1,700 Latino high school students from across Indiana with valuable information on getting to and through college. Students attended workshops such as: How to Choose a College that Best Fits Your Needs, Financial Aid 101, and What You Need to Know About the Transition to College and ICHLA supported and sponsored it. We provide orientation about discrimination and provide material in Spanish and English regarding such an important information about equal opportunity.







### Girl Scouts of Central Indiana


