#### c. Review of ALJ Decisions and Orders

i. Gavin v. Stadens, Inc., (ICRC No.: EMra16101525)

Date of Initial Decision: 1/10/20

After reviewing briefs submitted by Complainant and Respondent and after conducting an oral argument, the ALJ granted Respondent's Motion for Summary Judgment. The ALJ dismissed the complaint, finding that no discrimination occurred. No objections have been filed.

#### ii. Evens v. Lamb Mechanical, (EMha18010010)

Date of Initial Decision: 1/10/20

The Parties moved for the dismissal of this matter after executing a settlement agreement. The ALJ granted the Parties' request.

## iii. Williams v. Golf View Appartments, (ICRC No.: HOrt13011688)

Date of Initial Decision: 12/13/20

After conducting a hearing on the mertis, the ALJ issued an initial decision in which the ALJ found that Respondent did not discriminate against Complainant and dismissed the complaint. Complainant has filed objections. The Commission set a briefing deadline of March 18, 2020 and an oral argument date of April 17, 2020.
