Introduction of Orders by Administrative Law Judge

*Synopses of Orders are not decisions, but are for informational purposes only.

1. Erica Shannon v. Pedcor management Corporation, Princeton Lake Apartments, HOfs16101514.

After receiving the Oral Argument and completing its administrative review, the Commission "shall issue a final order: (1) affirming; (2) modifying; or (3) dissolving" the Administrative Law Judge's order, in whole or in part, and may remand the matter with or without instructions to the Administrative Law Judge for further proceedings. Ind. Code § 4–21.5–3–29(b). Generally, the Commission's "final order disposing of a proceeding or an order remanding an order to an administrative law judge for further proceedings shall be issued within sixty (60) days after...the close of oral argument." IC 4-21.5-3-27&29.

VII. C.R.E.A.T.E. Leadership Program: Presentations

The purpose of the CREATE Leadership Program is to provide an opportunity for young adults to give input on civil rights issues and the state of civility within communities throughout Indiana. "C.R.E.A.T.E Leaders" are talented and highly motivated young adults who are interested in contributing to the development of research studies that seek to study the problems of discrimination in the areas of Employment, Housing, Public Accommodations, Education and Credit when based on race, religion, color, sex, handicap, national origin, or ancestry.
