PROPOSED FINDINGS OF FACT, CONCLUSIONS OF LAW, AND ORDER

On December 7, 2017, Claudia White ("Complainant") filed her Stipulation of Dismissal with Prejudice ("Stipulation"). Having carefully considered the foregoing and being duly advised in the premises, the presiding Administrative Law Judge ("ALJ") for the Indiana Civil Rights Commission ("ICRC"), Hon. John F. Burkhardt, HEREBY PROPOSES that the ICRC enter the following findings of fact, conclusions of law, and order.

FINDINGS OF FACT

- 1. Complainant filed the subject Complaint of Discrimination on September 27, 2016, naming Thomas Carr Howe High School and Charter Schools USA, alleging unlawful retaliation in violation of the Indiana Civil Rights Law, Ind. Code 22-9 ("the ICRL").
- 2. On July 14, 2017, the ICRC Director issued a Notice of Finding, finding probable cause to believe a violation of the ICRL had occurred.
 - 3. At a July 27, 2017 status conference, the parties reported successful conciliation efforts.
- 4. On December 7, 2017, Complainant stipulated to the disposition: dismissal with prejudice. Complainant filed the Stipulation before a hearing on the record had begun.
- 5. There is no evidence of fraud, coercion, duress, or any other reason not to grant the requested dismissal.
- 6. Any Conclusion of Law that should have been deemed a Finding of Fact is hereby adopted as such.

CONCLUSIONS OF LAW

- 1. The Commission has jurisdiction over the subject matter and the parties.
- 2. The parties did not file a "consent agreement" requiring approval by and signature of a majority of the commissioners and enforceable as a final order. IC 22-9-1-6(o); 910 IAC 1-3-4
- 3. Administrative review of this proposed decision may be obtained by the filing of a writing identifying with reasonable particularity each basis of each objection within fifteen (15) days after service of this proposed decision. IC 4-21.5-3-29(d).
- 4. Any Finding of Fact that should have been deemed a Conclusion of Law is hereby adopted as such.

ORDER

1. Complainant's Complaint of Discrimination is DISMISSED, with prejudice.
