1 1:10 o'clock p.m. December 20, 2019 2 CHAIRMAN RAMOS: I call to order the 3 4 meeting of the Indiana Civil Rights Commission 5 public meeting of December 20th, 2019. It is 6 1:10 in the afternoon. My apologies for being a little bit late. Our staff have some doors that 7 they've decorated, and we were given a quick 8 The rest of the Commissioners will want to 9 tour. do that before we leave today. 10 We have a full agenda in front of us. 11 We 12 have a -- we do have a quorum, so thanks be to everyone for being here, and Happy Holidays. 13 Ι 14 would like an announcement of the agenda, 15 Ms. Tracy. MS. RICHARDSON: Yes. We will 16 17 approve the previous minutes. We will have the ICRC's Director's Report, and actually, the 18 Director is not going to be here today. 19 He has a 20 meeting at the Governor's Office, but this has been submitted to each individual. If you don't 21 22 have a copy, let us know, please. We are working 23 on getting all of your information to you.

22	We have the Director's Report, and you	
23	mentioned that you've handed that out to us.	

MS. RICHARDSON: It's been given to 1 2 you. CHAIRMAN RAMOS: And we did speak 3 4 briefly with the Executive Director Wilson before we came in, and he apologizes for not being able 5 to join us, but there is a meeting with the 6 7 Governor, and we know he needs to be there for that. 8 From the meeting standpoint, I'm just 9 looking at it quickly to see if there's any 10 11 questions that anyone might have. I don't see 12 anything that sticks out. Commissioners, do you have any questions or -- any questions that you 13 14 want to address with Ms. Tracy? 15 Would you identify yourself as well? MS. RICHARDSON: 16 Yes. My name is 17 Tracy Richardson, and I'm the new hire. I am the precause investigative attorney for the Indiana 18 19 Civil Rights Commission. So, I'll be aiding and 20 assisting with the Intake Unit as well as the 21 Investigation Unit on the precause aspect of 22 complaints that are filed before the Commission, 23 to make sure that they are following our statute

and that we are protecting the citizens of 1 Indiana's constitutionally protected right to not 2 be subject to unlawful discrimination. 3 4 So, we want to make sure that everything 5 we bring before you is going to be within the 6 four corners of the statute for the Indiana Civil 7 Rights Commission, so we're going to be working together to do that. 8 CHAIRMAN RAMOS: Okay. Thank you. 9 Commissioners, any questions on that part? 10 COMM. SLASH: My only question on the 11 November Agency at a Glance is this -- it says 12 it's a change from July. Is that a typo? Is it 13 14 a change from October? MS. RICHARDSON: I did not do the 15 typing, so I'm not -- I'm not aware --16 17 COMM. SLASH: Okay. 18 MS. RICHARDSON: -- of how that was 19 handled. 20 COMM. SLASH: Okay. That's my only 21 main question. CHAIRMAN RAMOS: Any news on a new 22 23 Deputy Director?

MS. RICHARDSON: There's no news yet 1 with respect to the Deputy Director. 2 CHAIRMAN RAMOS: How about the Docket 3 4 Clerk, which it was Anehita? 5 MS. RICHARDSON: I believe they are looking at a Docket Clerk. They do have a 6 7 contractor that's being trained currently, but they are looking to hire someone full time. 8 CHAIRMAN RAMOS: Okay. 9 Thank you. 10 MS. RICHARDSON: Uh-huh. 11 CHAIRMAN RAMOS: Are there any other questions, Commissioners? 12 13 (No response.) 14 CHAIRMAN RAMOS: Hearing none, let's 15 move on. COMM. BLACKBURN: I just want to say 16 17 welcome. 18 MS. RICHARDSON: Thank you. Thank 19 you. I appreciate it. 20 CHAIRMAN RAMOS: Thank you, Alpha. 21 Very true, we all welcome you to the Indiana 22 Civil Rights Commission. 23 MS. RICHARDSON: Thank you.

1 CHAIRMAN RAMOS: And if there are any 2 questions that we can answer, it's probably best 3 to go to Greg, but we're certainly open to any 4 conversations.

5 The next item on the agenda is the Old 6 Business, and we have several cases that are outstanding to review. In the case of the -- of 7 Veronica Zimchik [sic] versus Northern Indiana 8 Public Service Company, it is my recommendation 9 that we uphold the Director's finding of no 10 probable cause. I need a motion to approve. 11 COMM. JACKSON: So moved. 12 13 CHAIRMAN RAMOS: I need a second. COMM. SLASH: 14 Second. 15 CHAIRMAN RAMOS: All those in favor, signify by saying aye. 16 17 COMM. JACKSON: Aye. 18 COMM. HARRINGTON: Aye. 19 COMM. SLASH: Aye. 20 COMM. BLACKBURN: Aye. 21 CHAIRMAN RAMOS: Aye. 22 Any opposed? 23 (No response.)

CHAIRMAN RAMOS: The motion carries. 1 The next case is Vice-Chair Slash. 2 3 COMM. SLASH: Sure. In the case of Rick Cavaness versus Aramark, I'd like to uphold 4 5 the finding of no probable cause. 6 CHAIRMAN RAMOS: I need a motion to 7 approve. 8 COMM. HARRINGTON: So moved. CHAIRMAN RAMOS: I need a second. 9 COMM. JACKSON: Second. 10 CHAIRMAN RAMOS: All those in favor, 11 signify by saying aye. 12 13 COMM. JACKSON: Aye. 14 COMM. HARRINGTON: Aye. COMM. SLASH: Aye. 15 16 COMM. BLACKBURN: Aye. 17 CHAIRMAN RAMOS: Aye. Any opposed? 18 19 (No response.) 20 CHAIRMAN RAMOS: The motion carries. Comm. Harrington. 21 22 COMM. HARRINGTON: In the case of 23 Tony Finch versus Aramark, I recommend that we

1 uphold the no finding of probable cause. 2 CHAIRMAN RAMOS: I need a motion to 3 approve. COMM. SLASH: So moved. 4 5 CHAIRMAN RAMOS: I need a second. 6 COMM. JACKSON: Second. 7 CHAIRMAN RAMOS: All those in favor, signify by saying aye. 8 COMM. JACKSON: Aye. 9 10 COMM. HARRINGTON: Aye. 11 COMM. SLASH: Aye. COMM. BLACKBURN: Aye. 12 13 CHAIRMAN RAMOS: Aye. 14 Any opposed? 15 (No response.) 16 CHAIRMAN RAMOS: The motion carries. 17 Comm. Blackburn. 18 COMM. BLACKBURN: The case is 19 Kimberly Perez versus American Senior Communities 20 doing business as Eagle Care, LLC. I move that we uphold the Director's finding of no probable 21 22 cause. 23 CHAIRMAN RAMOS: I need a motion to

1 approve. COMM. SLASH: So moved. 2 CHAIRMAN RAMOS: I need a second. 3 COMM. HARRINGTON: 4 Second. 5 CHAIRMAN RAMOS: All those in favor, 6 signify by saying aye. 7 COMM. JACKSON: Aye. COMM. HARRINGTON: 8 Aye. COMM. SLASH: Aye. 9 10 COMM. BLACKBURN: Aye. CHAIRMAN RAMOS: 11 Aye. Any opposed? 12 13 (No response.) 14 CHAIRMAN RAMOS: The motion carries. We are now in New Business, so in the 15 Appointment of Commissioners to Appeals Courts, 16 Charles Andrews versus BMV. Is there anyone 17 18 here -- Mr. Andrews? Are you Mr. Andrews? 19 MR. ANDREWS: Yes. 20 CHAIRMAN RAMOS: Sir, it is my understanding that you were not able to provide 21 all of the information in a timely manner. Would 22 23 you like to address that for us?

MR. ANDREWS: I don't know what that 1 I've got all of the information with me 2 means. now, asking for a reinvestigation. So, that's 3 4 why I'm here. This is a letter I got from ICRC, telling me to be here today -- or asking me to be 5 here. I have a question: What's a quorum? 6 7 CHAIRMAN RAMOS: It means we have to have a majority of Commissioners here, which we 8 9 do have a quorum. MR. ANDREWS: Okay. You said there's 10 11 no oral arguments. I don't know what that means. I have to talk in order to ask for a 12 re-evaluation. 13 14 CHAIRMAN RAMOS: It is my 15 understanding that they had not received information in a timely manner, but that we have 16 17 the opportunity, if you have additional information that you would like to submit, we can 18 approve that. The information will go to 19 20 Ms. Tracy, and Ms. Tracy will distribute it to whatever Commissioner is assigned to that case. 21 22 MR. ANDREWS: Okay. Well, what do 23 you mean by "a timely manner"? I have filed my

appeal on time and I'm here on time. What is not 1 in a timely manner? 2 CHAIRMAN RAMOS: Ms. Tracy will --3 4 MS. RICHARDSON: There's a statutorily prescribed deadline for filing an 5 appeal. I am not involved in that part of the 6 7 process, but apparently it was found that you had not submitted your documentation within that 8 9 statutorily prescribed time. MR. ANDREWS: Well, that's not true. 10 I came down in person to submit it. I think I 11 had a week or two to go, and they accepted it and 12 13 told me I was -- had plenty of time. I was 14 before the deadline, so I have no idea what that 15 means. CHAIRMAN RAMOS: So, Mr. Andrews, 16 17 as -- from the Commission's standpoint, since there is some level of confusion and you have 18 some additional information, we will allow that 19 20 you provide that information to --21 MR. ANDREWS: Okay. 22 CHAIRMAN RAMOS: -- Ms. Tracy, and it 23 will be distributed through the Commission.

1 MR. ANDREWS: All right. And Mr. Diaz Dyer, I think, was supposed to call me 2 back with the name of the investigator that was 3 on this case for the last year and a half. 4 They made me wait a year and a half before I received 5 6 the finding. I never knew the name of the investigator, or if I did a long time ago, I 7 forgot it, and I haven't heard from him. He's 8 not here today, per chance, is he? 9 10 MS. RICHARDSON: Who's your investigator? 11 MR. ANDREWS: Pardon? 12 13 MS. RICHARDSON: Who is your 14 investigator? 15 CHAIRMAN RAMOS: I don't think he 16 knows. 17 MR. ANDREWS: I don't know. 18 MR. HEALY: He doesn't know. 19 MR. ANDREWS: He was supposed to 20 come, but I don't know who it was. 21 MS. RICHARDSON: Who -- is there a 22 name on your --23 CHAIRMAN RAMOS: We'll accept that as

to provide you an answer before you leave today, 1 so if you give the information to Ms. Tracy, 2 we'll also get an answer for you on who that 3 4 investigator is. 5 MR. ANDREWS: Okay. Who's Ms. Tracy, 6 now? Is that --7 MS. RICHARDSON: I'm --CHAIRMAN RAMOS: This is Ms. Tracy. 8 9 MS. RICHARDSON: May I ask: Is that only your complaint that you have with you? 10 MR. ANDREWS: This is all of the 11 12 information you need for a re-evaluation. Can I 13 briefly describe what it is --14 MS. RICHARDSON: You must --15 MR. ANDREWS: -- two or three minutes? 16 17 CHAIRMAN RAMOS: It is more relevant to go --18 19 MR. ANDREWS: Yes. 20 CHAIRMAN RAMOS: Excuse me, sir. Once it has been reviewed by our administrative 21 group, then they make a recommendation to us, and 22 23 then we review it at that time. So, since it's

new information, we want to follow the process, 1 and that gives it to Ms. Tracy. She'll handle 2 that process and go from there. 3 MR. ANDREWS: Well, this is the new 4 5 information, this is the old. Do I give this --6 when I give this to you, should I say, "Here is 7 the proof for this, here is the proof for that"? Should I make any statements so you'll understand 8 9 what I'm giving you? 10 MS. RICHARDSON: No, you can just submit your documentation to the Commission, and 11 the Commission will go through it, and --12 13 MR. ANDREWS: You think they can 14 figure it out? 15 MS. RICHARDSON: -- and if there are 16 any questions, they can come back --17 MR. ANDREWS: Okay. MS. RICHARDSON: -- and go over it. 18 CHAIRMAN RAMOS: 19 They're thorough. 20 They're thorough, Mr. --21 MR. ANDREWS: All right. 22 CHAIRMAN RAMOS: -- Andrews. 23 I'm a little leery of MR. ANDREWS:

that, because I remember being told if they had 1 any questions, they would contact me a year and a 2 half ago, and I never heard from them for a year 3 They didn't call me to fact check 4 and a half. anything, and I would appreciate it if they would 5 call me if they have any questions at all. But I 6 7 would like to explain what this new information is, but you're saying I cannot do that, I just 8 have to give it to you? 9 10 MS. RICHARDSON: You don't have a --11 MR. ANDREWS: I want to make sure it's clear. 12 13 MS. RICHARDSON: -- statutorily 14 protected right to do that. That's in the discretion of the Chair. 15 MR. ANDREWS: Okay. Well, all right. 16 17 I'll be giving you this, then. This is all of the new information I have, because when I filed 18 initially in April of 2018, I filed prematurely. 19 20 I had no idea what was going on at the time, and I didn't know what the BMV was up to and what 21 22 they were all about. I didn't know -- well, but 23 after April 2018, I discovered what they were all

1 about and what they were up to.

And so, I have all of the proper 2 information, the facts, a complete discovery with 3 all of the truth in this stack. 4 So, I'd like for the ICRC to reinvestigate, because the initial 5 investigation was completely false, because the 6 IR -- ICRC received false information from the 7 BMV, and I have the proof of that in here, which 8 I will be giving to you. 9 10 CHAIRMAN RAMOS: So, Mr. Andrews, I 11 will personally take that case from an appointment standpoint. 12 13 MR. ANDREWS: Okay. 14 CHAIRMAN RAMOS: So, if you want to 15 provide the information to Ms. Tracy, and then if there are questions in it and we get through it, 16 17 then we will contact you directly. 18 MR. ANDREWS: Okay. 19 CHAIRMAN RAMOS: And you know who is 20 assigned to the case; okay? 21 MR. ANDREWS: Do you want me to give 22 it to you right now? 23 MS. RICHARDSON: Sure, yes, you can

1 do that.

2 COMM. JACKSON: And you're talking 3 about your originals; right?

MR. ANDREWS: No, those are copies. You can keep them. You can make copies. I don't care if you return them to me or not. You can keep them. You can dispense them to anybody else in the state if you want to. I do not need them back. They're yours.

10	COMM. JACKSON: Thank you.
11	COMM. SLASH: Thank you.
12	CHAIRMAN RAMOS: Thank you.

MR. ANDREWS: And what I have here is 13 14 the old information I gave the ICRC in April of 2018, before I knew what was going on, so I 15 16 gave them some very sketchy material that they 17 couldn't possibly make a proper finding from. Ι get confused and completely uninformed when I 18 read them myself. That's how little I knew in 19 20 April of 2018, so this is a copy of everything I gave you people in April of 2018. It should be 21 22 thrown away, into the wastebasket, because it's 23 totally useless. That is a hundred percent

1 useful.

2

CHAIRMAN RAMOS: Okay.

MR. ANDREWS: The only thing that you 3 4 had that was proper in April of 2018 was a copy of my testing history from the BMV, which showed 5 that I passed every test, no problem, every test 6 7 the BMV had. So, my suspension is illegal in the first place, and I explain in there why they went 8 9 ahead and suspended me anyway. But that's all they had, and so, they should have and could have 10 11 noticed that something was wrong. Why did the 12 BMV suspend me when I did nothing wrong, passed every test, and --13 14 CHAIRMAN RAMOS: Thank you, I -- we appreciate this. 15 Mr. Andrews. 16 MR. ANDREWS: Yeah. Okav. 17 CHAIRMAN RAMOS: This is not an open forum. 18 19 MR. ANDREWS: Okay. 20 CHAIRMAN RAMOS: Please pass the 21 information to Ms. Tracy. 22 MR. ANDREWS: But they did call and 23 ask me, so that's the only point I was making.

CHAIRMAN RAMOS: Thank you. 1 MR. ANDREWS: So, I'm going to keep 2 these and throw them away, because you have all 3 4 of this anyway from April of 2018. 5 CHAIRMAN RAMOS: Thank you. MR. ANDREWS: I just wanted to 6 emphasize that -- why it's useless and that the 7 BMV, when they responded in May of 2018 to you 8 people, they completely lied. And I had in there 9 a line-for-line expose of their lies, with the 10 proof and evidence behind it. 11 12 CHAIRMAN RAMOS: Thank you. 13 All right. Let's move to the next item on 14 the agenda. The next item is --MR. ANDREWS: Am I finished and can 15 leave, or --16 17 CHAIRMAN RAMOS: Yes, you -- I appreciate you giving the information to our --18 19 thank you. 20 MR. ANDREWS: Okay. 21 CHAIRMAN RAMOS: The next item is the 22 motion Linda Williams versus Golf View 23 Apartments, and if you read through the motion,

they are requesting an approval of an additional 1 15 days, and both parties are in agreement with 2 that. So, since they are both in approval, I 3 recommend that we have a motion to approve the 4 5 15-day extension. 6 COMM. SLASH: So moved. 7 CHAIRMAN RAMOS: I need a second. COMM. BLACKBURN: Second. 8 9 CHAIRMAN RAMOS: Any opposition or questions? 10 11 (No response.) CHAIRMAN RAMOS: All those in favor, 12 13 signify by saying aye. 14 COMM. JACKSON: Aye. COMM. HARRINGTON: Aye. 15 16 COMM. SLASH: Aye. 17 COMM. BLACKBURN: Aye. 18 CHAIRMAN RAMOS: Aye. 19 Any opposed? 20 (No response.) CHAIRMAN RAMOS: The motion carries. 21 The next items are the reviews for the 22 23 Administrative Law Judge Decisions and Orders.

In the case of Turner verses Mercedes-Benz, this 1 is a dismissal that -- on a discrimination suit, 2 and since neither party is -- since neither party 3 4 has had any objections to dismiss this, I 5 recommend that we approve the motion for the 6 ALJ's dismissal. I need a motion to approve. COMM. SLASH: 7 So moved. CHAIRMAN RAMOS: I need a second. 8 COMM. JACKSON: 9 Second. 10 CHAIRMAN RAMOS: All those in favor, signify by saying aye. 11 12 COMM. JACKSON: Aye. 13 COMM. HARRINGTON: Aye. 14 COMM. SLASH: Aye. COMM. BLACKBURN: 15 Aye. CHAIRMAN RAMOS: 16 Aye. 17 Any opposed? 18 (No response.) 19 CHAIRMAN RAMOS: Motion carries. In 20 the next case of Brownson versus Finzel's Mastertech, the parties have jointly filed a 21 22 timely notice of election, and the ALJ has 23 dismissed the complaint and neither party has

objected. I recommend we have a motion to 1 2 approve. COMM. SLASH: So moved. 3 CHAIRMAN RAMOS: I need a second. 4 5 COMM. HARRINGTON: Second. CHAIRMAN RAMOS: Any questions or 6 discussion? 7 8 (No response.) CHAIRMAN RAMOS: All those in favor, 9 signify by saying aye. 10 COMM. JACKSON: Aye. 11 COMM. HARRINGTON: Aye. 12 COMM. SLASH: Aye. 13 14 COMM. BLACKBURN: Aye. 15 CHAIRMAN RAMOS: Aye. 16 Any opposed? 17 (No response.) CHAIRMAN RAMOS: The motion carries. 18 19 The next case is ICRC (Kelly) versus 20 Lafayette Urban Ministry. In this case, the ALJ is recommending dismissal of the complaint under 21 the Indiana Fair Housing Act because under this 22 23 complaint, it was -- I'm sorry -- it was filed in

a timely manner to dismiss the complaint against 1 the Indiana Fair Housing Act. The complaint 2 under the Civil Rights prong was not dismissed 3 and remains in the administrative forum. 4 So --COMM. SLASH: Can we have a little 5 6 clarity about what that means? MS. RICHARDSON: Well, the Respondent 7 has filed a timely notice of election, so the 8 Respondent is going to State Court, and once that 9 occurs, by statute, then you all will dismiss the 10 complaint before the Commission --11 12 CHAIRMAN RAMOS: Yeah. 13 MS. RICHARDSON: -- because they're 14 going to State Court. 15 COMM. SLASH: All right. CHAIRMAN RAMOS: So, there's one bite 16 17 at the apple, and this case is going to State Court. 18 COMM. SLASH: All right. 19 I move that 20 we dismiss this case. 21 CHAIRMAN RAMOS: I need a second. 22 COMM. HARRINGTON: Second. 23 COMM. JACKSON: Second.

1 CHAIRMAN RAMOS: All those in favor, signify by saying aye. 2 COMM. JACKSON: Aye. 3 COMM. HARRINGTON: 4 Aye. 5 COMM. SLASH: Aye. COMM. BLACKBURN: 6 Aye. 7 CHAIRMAN RAMOS: Aye. Any opposed? 8 9 (No response.) CHAIRMAN RAMOS: The motion carries. 10 The fourth case is the case of Garcia 11 versus the Garden Table, and the ALJ has granted 12 13 Respondent's request for default judgment. Is 14 Mr. Garcia here today, or anyone representing Mr. Garcia? 15 16 (No response.) 17 CHAIRMAN RAMOS: Hearing none, then I recommend that we uphold the default judgment as 18 recommended by the ALJ. I need a motion to 19 20 approve. 21 COMM. SLASH: So moved. 22 CHAIRMAN RAMOS: I need a second. 23 COMM. JACKSON: Second.

CHAIRMAN RAMOS: All those in favor, 1 2 signify by saying aye. COMM. JACKSON: Aye. 3 4 COMM. HARRINGTON: Aye. 5 COMM. SLASH: Aye. COMM. BLACKBURN: 6 Aye. 7 CHAIRMAN RAMOS: Aye. The motion carries. 8 Okay. That takes us to the meeting dates. 9 In conversation with the Executive Director's 10 11 Office, these dates are tentative. The one for 12 sure will be on the 17th of January, but the others, particularly the one in June, when we 13 14 have the housing event and stuff, that one may fluctuate, so that one's not quite firm. 15 COMM. HARRINGTON: And July, that 16 17 usually conflicts with our meeting of the Governors. 18 19 CHAIRMAN RAMOS: Yeah. 20 COMM. SLASH: And our Board is 21 directly on that date this year. 22 CHAIRMAN RAMOS: Yeah. So, it is --23 don't put it on your calendars yet. We'll review

1 them all in January. COMM. HARRINGTON: So, June and July? 2 CHAIRMAN RAMOS: Yes. 3 COMM. HARRINGTON: Thank you. 4 5 COMM. SLASH: Okay. CHAIRMAN RAMOS: Any other questions 6 as far as meeting dates are concerned? 7 8 (No response.) CHAIRMAN RAMOS: All right. 9 So the 17th. They're doing some kind of activity on 10 the 17th as well, as I recall. 11 MS. RICHARDSON: I'm not sure. 12 13 COMM. SLASH: Oh, that should be the 14 placing of the wreath. CHAIRMAN RAMOS: 15 It is. 16 COMM. SLASH: It's the Friday before. 17 CHAIRMAN RAMOS: Yes, it is. 18 COMM. HARRINGTON: The 17th? 19 COMM. SLASH: Uh-huh. 20 COMM. HARRINGTON: You're right. COMM. SLASH: Uh-huh. 21 22 CHAIRMAN RAMOS: That, and then is 23 there -- is that the service day as well?

COMM. SLASH: Yes, but that generally 1 falls the first half of the day. Do you all 2 know, office-wise, what you're doing yet? 3 4 MS. RICHARDSON: No, we haven't 5 discussed it. COMM. SLASH: Okay. 6 7 CHAIRMAN RAMOS: Okay. And the --COMM. SLASH: It's normally a 8 10:00-to-12:00 situation. 9 CHAIRMAN RAMOS: And then the Martin 10 Luther King celebration is on that Monday? 11 MS. RICHARDSON: I believe so. 12 Ι believe so. 13 14 COMM. SLASH: The service generally -- the service project falls with that. 15 The placing of the wreath is on Friday. 16 17 CHAIRMAN RAMOS: Okay. All right. So, put that on your calendar. Both are great 18 events to participate in. I know all of you 19 20 have, so no news there. The next item is on the Announcements. 21 Do we have any announcements? 22 23 MR. GILES: Excuse me. My name is

Virgil Giles, and I'm the Deputy Director for 1 External Affairs, and the wreath placement date 2 is the 15th, the Statehouse ceremony is on 3 4 the 16th, and the 20th is the day of service. COMM. HARRINGTON: Can you state 5 those again? 6 7 MR. GILES: Yes. The wreath placement is on January 15th, the Statehouse 8 ceremony is on the 16th, and the day of service 9 is on the 20th. 10 11 COMM. SLASH: Awesome. CHAIRMAN RAMOS: So, Virgil, you're 12 picking up with the communications and all of 13 14 that good stuff? 15 MR. GILES: Correct. CHAIRMAN RAMOS: Okay. So, again, 16 17 welcome. We're glad that you're here. I believe Lisa's still around as well; correct? 18 19 MR. GILES: Yeah, she's contracting 20 by paid media. 21 CHAIRMAN RAMOS: Okay. So, one of 22 the things that I found in conversations with 23 Commissioners -- I've met with some of the other

Commissioners in the Cultural Affairs, with the
 Native American and the -- actually the Martin
 Luther King Commission.

We're just trying to get a good sense of -- know what's going on with them and how we can be of help as a collective group, and they have a lot of other things that are going on that we don't always see. There are a couple of major Native American events that happened in the November time frame.

11 MR. GILES: Yes.

12 CHAIRMAN RAMOS: One was on a 13 Saturday and one was on a Tuesday, which was a 14 breakfast with the legislature. And it would be 15 neat if we could get all those into our community thing, so if we would like to attend one for the 16 17 men or for the Native Americans or for the Latinos, it's just kind of nice to know those 18 things are out there. I know we all have a lot 19 20 of things going on, but it's nice to be able to 21 participate. 22 COMM. SLASH: I was going to say you

23 guys can also include us in a calendar

appointment. If you have --1 MS. RICHARDSON: Okay. 2 COMM. SLASH: -- one on the staff, 3 just include us in that. 4 5 MR. GILES: Okay. COMM. SLASH: We would gladly take a 6 calendar appointment. 7 MR. GILES: Okay. I apologize for 8 any miscommunication before me, but that won't 9 10 happen while I'm here, so --CHAIRMAN RAMOS: You know that's on 11 public record. 12 13 MR. GILES: It's on public record. Ι 14 stand by my name. COMM. SLASH: You cannot offend us by 15 sending a calendar appointment. 16 17 MR. GILES: Okay. All right. 18 CHAIRMAN RAMOS: And do you do that, 19 Virgil, for all of the Commissions? 20 MR. GILES: Yes. All of the Commissions report directly to me, and I support 21 them and all of the statutes. 22 23 CHAIRMAN RAMOS: Okay. Good.

COMM. SLASH: I'll see them before I 1 2 leave anyway. MR. GILES: Okay. Thank you. 3 CHAIRMAN RAMOS: You're welcome. 4 We 5 appreciate that. MR. GILES: 6 Thank you. 7 CHAIRMAN RAMOS: And are there any other events, now that we have you, that are 8 coming up in the next 60 days that we should have 9 on our calendars? 10 11 MR. GILES: Yes. The Indiana Young Black Males Matters Conference, that's going to 12 be February 25th, and I have a location. 13 That's 14 going to be at the Statehouse, and that's going to be from 9:30 a.m. to 2:30 p.m. 15 And then everything else is starting in early April, and 16 17 I'll make sure that you get all of that information. 18 19 CHAIRMAN RAMOS: Okay. 20 COMM. SLASH: Thank you. CHAIRMAN RAMOS: Commissioners -- I'm 21 22 sorry. Vice-Chair Slash, the 21st of February I 23 will be out of the country, so if you would put

that on your plate to chair that --COMM. SLASH: Got it. CHAIRMAN RAMOS: -- I would appreciate it. Any other announcements? (No response.) CHAIRMAN RAMOS: Any public comment? (No response.) CHAIRMAN RAMOS: Hearing none, nothing else to cover, then I motion to adjourn. All right. Thank you. Thereupon, the proceedings of December 20, 2019 were concluded at 1:36 o'clock p.m.
