# **Conference** Overview

The Indiana Civil Rights Commission (ICRC), the Indiana Housing and Community Development Authority (IHCDA), and the U.S. Department of Housing and Urban Development (HUD), hope to bring greater awareness and understanding regarding rights and responsibilities under fair housing laws with their 2016 State of Indiana Fair Housing Conference. The Federal Fair Housing Act, originally signed on April 11, 1968, protects individuals from housing discrimination. Despite being in federal law for 48 years, individuals are still being treated unfairly due to their race, color, national origin, disability, religion, gender and for having children under the age of 18. Indiana also has a state fair housing law which provides the same protections as well as the addition of ancestry.

### Conference highlights include:

- A detailed review of state and federal fair housing laws and the protected groups
- An examination of efforts to eliminate housing discrimination across the United States
- A thorough analysis of guidance, regulations and case law
- The release and presentation of the 2015 results of ICRC's Statewide Fair Housing Testing Program

#### **KEYNOTE LUNCHEON**

#### Anti-integrationist Violence: America's Hidden Barrier to Full Housing Rights - 1 CLE credit

Jeannine Bell, J.D., Ph.D. is the Richard S. Melvin Professor of Law at Indiana University Maurer School of Law.

In contemporary America it is easy to assume that battles over whether individuals can occupy the same neighborhood are a thing of the past. Racial tolerance scores and other measures of racial progress, like interracial marriage, are at their highest levels, the most powerful person in the world, the president of the United States is African-American, and the current and previous Attorney Generals have been African-American. These markers of progress aside, housing in this country remains stubbornly racially segregated. This presentation will address a particular form of housing violence – anti-integrationist violence that remains largely hidden and serves as a barrier to full housing rights.

### Mortgage Foreclosure Trial Court Assistance Program - 1 CLE credit

This presentation will focus on Ms. Brown's knowledge and experience as a Facilitator for the Indiana Supreme Court Mortgage Foreclosure Trial Court Assistance Program. She mediates mortgage foreclosure settlement conferences for Marion County Courts, in accordance with the federal Home Affordable Modification Program (HAMP) and Indiana Code §32-30-10.5 et seq. Ms. Brown will discuss the process of the program that sometimes leads to telephone settlement conferences in order to help the parties reach an agreement. She will answers questions and discuss concerns relating to foreclosure proceeding.

### A Dialogue with Fair Housing Experts: History, Evolution, and the Impact of Fair Housing Laws - 1 CLE credit

#### Rollout of Statewide Testing Results in Indiana - 1.0 CLE credit

Ja'Neane Minor and Tammy Butler Robinson from Engaging Solutions and Kimberly Simmons and Melissa Deering from the Indiana Civil Rights Commission will present the results of the 2015 testing program. The Indiana Civil Rights Commission launched the country's first statewide testing program in 2014. This program, designed to identify and assess instances of housing discrimination experienced by various communities, concluded its initial audit in December 2014. 2015 was spent retesting some locations as well as expanding the testing to cover more protected classes. This session will discuss the results of the 2015 testing program.

#### **CONCURRENT WORKSHOP SESSIONS**

#### Updates on Fair Housing Lending Practices and Predatory Lending - 1.0 CLE credit

Steve Tomkowiak, J.D., NFHTA Fair Housing Consultant - Lending discrimination claims, like other fair housing, employment and civil rights claims, can be established by direct (or overt) evidence of discriminatory intent, or by indirect, circumstantial evidence under a disparate treatment or disparate impact theory of liability. Lending discrimination claims have been successfully prosecuted in cases involving direct evidence of discriminatory intent, such as by HUD in recent maternity discrimination cases, and by the DOJ, HUD and private litigants in disparate impact cases using overall statistical analysis of a lender's lending practices. On the other hand, very few cases have been successfully filed and litigated under a disparate treatment theory of liability, comparing a lender's treatment of protected class borrowers with non-protected class borrowers.

#### Domestic Violence and Eviction Laws - 1.0 CLE credit

Michael D. Mitchell, J.D., NFHTA Fair Housing Consultant – Domestic Violence against women continues to be a major societal issue. Women are disproportionately evicted from housing as a result of domestic violence. This session will explore the protections that exist under the fair housing laws, and the Violence Against Women Act (VAWA) for victims of domestic violence, as well as the resources that exist to combat discriminatory practices that lead to eviction.

#### Occupancy Standards and Familial Status- 1.0 CLE credit

Allison Bethel, J.D., The John Marshall Law School –

#### Fair housing and Gender Bias - 1.0 CLE credit

Guest Speaker: Michael Mitchell, J.D. - This session will examine housing discrimination related to gender, and fair housing issues related to sexual orientation and gender identity. Topics that will be explored include: the nature and extent of sex discrimination in housing; gender protections under the Fair Housing Act; HUD's proposed rule regarding sexual harassment in housing; combatting housing discrimination against the LGBT community; and how to advocate for gender equality in housing

# Speaker Biographies

#### Jeanine Bell, J.D., Ph.D.

Richard S. Melvin Professor, U.S. Indiana University Maurer School of Law

A nationally-recognized scholar in the area of policing and hate crime, Bell has written extensively on hate crime and criminal justice issues. Her first book, Policing Hatred: Law Enforcement, Civil Rights, and Hate Crime (New York University Press 2002) is an ethnography of a police hate crime unit. Her book titled Police and Policing Law (Ashgate 2006) is an edited collection that explores law and society scholarship on the police. Her newest book is Hate Thy Neighbor: Move-in Violence and the Persistence of Racial Segregation in American Housing (NYU Press, 2013).

Bell's research is broadly interdisciplinary, touching on both political science and law. In that regard, she has written in the area of qualitative methodology and she is co-author of Gaining Access: A Practical and Theoretical Guide for Qualitative Researchers (AltaMira Press 2003). Her scholarship has appeared in the Harvard Civil Rights-Civil Liberties Law Review, Rutgers Race & the Law Review, Punishment and Society, and the Michigan Journal of Race and Law. An associate editor of the Law and Society Review, Bell has served a trustee of the Law and Society Association and as a member of the American Political Association's Presidential Taskforce on Political Violence and Terrorism. She was appointed Richard S. Melvin Professor of Law in 2015.

#### Allison Bethel, J.D.

#### Professor, The John Marshall Law School

Allison Bethel joined John Marshall Law School in April 2008 as a Clinical Professor and Director of its Fair Housing Legal Clinic. She is a Chicago native and graduate of Northwestern University. She received her law degree from the University of Florida. While in law school, she received numerous awards for advocacy including Best Oral Advocate, Best Brief Award and the Presidential Recognition Award.
