





- 3. CONTRACTOR SHALL SEED AND MULCH BORROW STOCKPILE ONCE GRADING AND TOPSOILING HAS BEEN COMPLETED. SEEDING FOR THIS AREA SHALL BE CONSIDERED INCIDENTAL TO OTHER WORK ITEMS.
- 4. CONTRACTOR SHALL TAKE CARE AS TO NOT DISTURB THE VEGETATIVE BUFFER AREA. ALL DISTURBANCE AS A RESULT OF CONTRACTOR OPERATIONS SHALL BE REPAIRED TO THE OWNER SATISFACTION AT NO ADDITIONAL COST.
