This letter shall serve as a formal notice of the receipt of an application for **Section 401 Water Quality Certification** by the Indiana Department of Environmental Management (IDEM). The purpose of the notice is to inform the public of active applications submitted for water quality certification under Section 401 of the Clean Water Act (33 U.S.C. § 1341) and to solicit comments and information on any impacts to water quality related to the proposed project. IDEM will evaluate whether the project complies with Indiana's water quality standards as set forth at 327 IAC 2.

5. Project Description:

Section 3 of the proposed I-69 Ohio River Crossing project will be constructed. Impacts from this roadway construction includes 12.79 acres of forested wetland impacts and 0.65 acre of open water impacts. Mitigation will be provided through the purchase of 51.81 acres of wetland credits from the Coles Creek Mitigation Bank. Any person or entity who wishes to submit comments or information relevant to the aforementioned project may do so by the closing date noted above. Only comments or information related to water quality or potential impacts of the project on water quality can be considered by IDEM in the water quality certification review process.




Public Hearing:


