#### Fastenal Company:

#### Fastenal Stores:

We acknowledge that the preferred ordering method is punch-out, which Fastenal will provide. In addition, it is important to note that Fastenal is different than traditional catalog suppliers in many ways.

- We have **86 Indiana locations** with sales and service available from the local site to service your needs.

- Fastenal's largest inventory **Distribution Center is in Indianapolis**. It supports our Indiana store locations.
- Fastenal Company stores stock inventory**, thus helping the state leverage QPA pricing and address stock out or emergency situations.
- Fastenal Company stores have the autonomy to stock inventory based on **the needs of our local customers**. This will be a significant benefit to your site because it will help alleviate inventory carrying costs, stock outs, increase efficiencies, and more.
- Fastenal Company operates a number of Vendor Managed Inventory (VMI) programs that are also aimed at driving down cost and increasing efficiencies.

## **Punch-out Catalog:**

The Fastenal Company's punch-out catalog available through the State's PeopleSoft system reflects items from the State's Market Basket as well as our extensive non-Market Basket product offering. Please note the following when using the catalog:

**IMPORTANT – PO Process: The standard ordering method is through punch-out catalog available through the State's PeopleSoft system:**

**IMPORTANT: Starting 11/29/2010, State of Indiana will start submitting PO's via Auto-Dispatch. Please reference Training information from IDOA.**

- Need help finding something?** If you cannot find what you're looking for, it does not mean Fastenal isn't the QPA holder for those items! Please contact your local Fastenal store to communicate your needs (state-use workcenter and PEN Product contract restrictions apply).
- Quotes or special item requests:** Items that are requested through the local store can be posted on the punch-out's **eVMI** function by the store. You can view and select the items you need and add them to your shopping cart!
- Repetitive orders:** The punch-out's **eVMI** function can also be utilized as a re-order template, or as an electronic vendor managed inventory tool.
- Need an ID to view the internet catalog, [www.fastenal.com](http://www.fastenal.com)?** No Problem! This is a benefit for State of Indiana employees that do not have access to the Punch-Out:
  - Contact your local Fastenal store to establish a log in account as a requester
  - Please be prepared to provide the following information:
    - o Name
    - o Email address & Phone number
    - o A user name and password

Your local Fastenal store will set up and enable your account to be used for viewing products, and prices.
