Subject: Recommendation of Selection for RFP 23-68162
Document Destruction Services

Based on its evaluation of responses to RFP 23-68162, it is the evaluation team's recommendation that **Federal Records Management** (North Region) and **Shredding & Storage Unlimited** (Central and South Region) be selected to begin contract negotiations to provide Document Destruction Services for the All-State Agencies. Proposals were evaluated and awarded on a regional basis.

The terms of this recommendation are included in this letter.

The evaluation team received four (3) proposals from:

1. Federal Records Management
2. Shredding & Storage Unlimited
3. Opportunity Enterprise/Secure Shred

The proposals were evaluated by State Agencies and IDOA according to the following criteria established in the RFP:

Criteria	Points
1. Adherence to Mandatory Requirements	Pass/Fail
2. Management Assessment/Quality (Business and Technical Proposal)	50
3. Cost (Cost Proposal)	30
4. Buy Indiana	5
5. Minority Business Enterprise Subcontractor Commitment	5 (1 bonus pt. available)
6. Women Business Enterprise Subcontractor Commitment	5 (1 bonus pt. available)
7. Indiana Veteran Owned Small Business Participation Plan	5 (1 bonus pt. available)

Total: 100 (103 if bonus awarded)

The proposals were evaluated according to the process outlined in Section 3.2 (“Evaluation Criteria”) of the RFP. Scoring was completed as follows:

A. Adherence to Requirements

Each proposal was reviewed for responsiveness and adherence to mandatory requirements. All of the Respondents were deemed responsive and adhered to the mandatory requirements.

B. Management Assessment/Quality (50 points)

The Respondents’ proposals were each evaluated based on their respective Business Proposal and Technical Proposal.

Business Proposal (5 points)

For the Business Proposal evaluation, the evaluation team considered the information the Respondents organizational structure and financial stability as defined in Section 2.3 of the RFP. The evaluation teams scores were based on a review of the Respondents Business Proposal, Attachment E.

Technical Proposal (45 Points)

For the Technical Proposal evaluation, the evaluation team considered the Respondents ability to effectively perform the scope of work in Section 2.4 of the RFP. The evaluation teams scores were based on a review of the Respondents Technical Proposal, Attachment F.

The evaluation team’s Round 1 scoring is based on a review of the Respondents’ proposed approach to each section of the Business Proposal and Technical Proposal. The initial results of the Management Assessment/Quality (MAQ) Evaluation are shown below:

C. Cost Proposal (30 points)

Cost scores would then be normalized to one another, based on the lowest cost proposal evaluated. The lowest cost proposal received a total of 35 points. The normalization formula is as follows:

- Respondents Cost Score = (Lowest Cost Proposal / Total Cost of Proposal) X 35*

The cost scoring across Clusters as a result of the Respondents’ cost proposals is as follows:

The evaluation team elected to issue Clarification Questions, Oral Presentations, and Best and Final Offers (BAFOs) requests to all Respondents.

E. Clarification Responses, Oral Presentations, and Post BAFOs

The Respondent's MAQ scores were reviewed and re-evaluated based on the Clarification Responses and Oral Presentations. The Respondent's cost scores were updated based on BAFOs. The scores for the Respondents after the Clarification Responses, Oral Presentations, and BAFOs were as follows:

F. IDOA Scoring

IDOA scored the Respondents in the following areas: Buy Indiana (5 points), MBE Subcontractor Commitment (5 points + 1 available bonus point), WBE Subcontractor Commitment (5 points + 1 available bonus point), and IVOSB Participation Plan (5 points + 1 available bonus point) using the criteria outlined in the RFP. When necessary, IDOA clarified certain Buy Indiana, M/WBE, and IVOSB information with the Respondents. Once the final Buy Indiana, M/WBE, and IVOSB forms were received from the Respondents, the final scores were tabulated as follows:
