#### **RESOLUTION 2004-57**

### CONCERNING THE RENEWAL OF SUPPLIER'S LICENSE

The Indiana Gaming Commission (Commission) adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6.

The Commission has considered the following factors:

- 1. On November 14, 2003, pursuant to RESOLUTION 2003-56, the Commission renewed the Supplier's License held by Chipco International.
- 2. In accordance with IC 4-33-7-8 and 68 IAC 2-2-8, a Supplier's License must be renewed annually along with payment of a Five Thousand Dollar (\$5,000) renewal fee.
- 3. The above-named licensee has requested renewal of licensure and the renewal fee has been paid in accordance with 68 IAC 2-2-3(c) and 68 IAC 2-2-8. The licensee may have outstanding background investigation fees and will be responsible for payment of the background fees. If payment for the background fees is not received as direct by the Commission staff, the license will be subject to non-renewal or revocation.
- 4. The Commission has determined that the above named Supplier Licensee remains in compliance with IC 4-33.

# NOW, THEREFORE, BE IT RESOLVED BY THE INDIANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:

#### **SECTION 1: SCOPE**

This resolution applies to the Supplier Licensee Chipco International.

#### **SECTION 2: DEFINITIONS**

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

#### SECTION 3: GRANT OF RENEWAL OF SUPPLIER'S LICENSE.

The Commission hereby grants the renewal of the Supplier's License issued to the supplier listed below on the condition that any outstanding background fees are paid as directed by the Commission staff. The Supplier's License will be valid for a period of one (1) year from the date of issuance.

# SECTION 4: CONDITIONS PLACED ON THE SUPPLIER'S LICENSE.

The Supplier Licensee must request renewal of the Supplier's License at least thirty (30) days before the expiration of the license and pay the Five Thousand Dollar (\$5,000) renewal fee in accordance with 68 2-2-3 (c) and 68 IAC 2-2-8.
