RESOLUTION 2004-61

A RESOLUTION GRANTING A PERMANENT SUPPLIER'S LICENSE TO GLOBAL SURVEILLANCE ASSOCIATES

The Indiana Gaming Commission ("Commission") adopts the following resolution pursuant to the authority granted to it under IC 4-33 and pursuant to 68 IAC 1-2-6:

The following factors have been considered by the Commission:

- 1. In accordance with IC 4-33-8 and 68 IAC 2-2, suitable applicants for a Supplier's License are issued a Supplier's License pending the completion of a background investigation. Supplier's Licenses are issued to applicants to supply goods and services to gambling operations licensed by the Indiana Gaming Commission.
- 2. After completion of a background investigation and pursuant to Resolution 2004-46, adopted by the Commission on August 5, 2004, the Supplier's License application submitted by Global Surveillance Associates was denied due to the fact that it conducted business at an Indiana riverboat without proper licensure.
- 3. Global Surveillance Associates submitted a request for a hearing regarding the denial of its application. Due to the fact that no additional issues regarding suitability were uncovered in the investigation, Commission staff recommends issuing a permanent Supplier's License to Global Surveillance Associates and Global Surveillance Associates agrees to pay a fine in the amount of \$12,000 for previously conducting business without a license. A Settlement Agreement has been executed by Commission staff and Global Surveillance Associates.
- 4. The action taken by Resolution 2004-46 is hereby withdrawn and the Commission is ready to issue a permanent Supplier's License to:

NOW, THEREFORE, BE IT RESOLVED BY THE INDANA GAMING COMMISSION, THAT THE FOLLOWING RESOLUTION IS ADOPTED:

SECTION 1. SCOPE.

This resolution applies to GLOBAL SURVEILLANCE ASSOCIATES.

SECTION 2. DEFINITIONS.

The definitions set forth in IC 4-33-2 and 68 IAC apply to this resolution.

SECTION 3. GRANT OF PERMANENT A SUPPLIER'S LICENSÉ FOR QUALIFIED APPLICANT.

The Commission hereby grants a permanent Supplier's License to the Supplier Licensee listed below. The permanent Supplier's License will be valid for a period of one (1) year, from October 1, 2004 through September 30, 2005.

GLOBAL SURVEILLANCE ASSOCIATES

SECTION 4. CONDITIONS PLACED ON SUPPLIER'S LICENSE.

Issuance of the Supplier's License is conditioned upon payment of the cost of the license investigation and the payment of the \$5,000 annual license fee in accordance with IC 4-33-7-1 and 68 IAC 2-2. Issuance is further conditioned upon payment of the \$12,000 disciplinary fine referenced above. Payment should be remitted to the Commission upon notice to Global Surveillance that a Supplier's License has been issued. Failure to remit payment may result in the revocation of the license.

SECTION 5. EFFECTIVE DATE.

This RESOLUTION is effective immediately.
