

ORDER 2011-74

AN ORDER AFFIRMING THE REVOCATION OF THE CRISIS CENTER, INC.'S ANNUAL BINGO LICENSE

The Indiana Gaming Commission ("Commission") hereby issues this Order approving the attached Order Granting Default Judgment issued by the Commission's Administrative Law Judge ("ALJ"). In support of this Order, the Commission states as follows:

1. The Crisis Center, Inc., ("Respondent") is a bona fide civic organization located in Kokomo, Howard County, Indiana.
2. Respondent conducts charitable gaming events under its Annual Bingo License #121373, which expires on May 31, 2011.
3. On September 22, 2010, Commission staff initiated a complaint for disciplinary action against Respondent to revoke Respondent's Annual Bingo License #121373 due to Respondent's violations of IC 4-32.2, 68 IAC 21, and IC 4-35-43-5-5(a).
4. Commission staff served notice on Respondent via First-Class Mail at 309 East Deffenbaugh Street, Kokomo, Indiana 46902.
5. On November 7, 2010, the ALJ in this matter set a Preliminary Hearing for November 10, 2010 at 9:00 a.m.
6. On November 10, 2010, Respondent participated in the Preliminary Hearing.
7. Subsequently, Respondent failed to file an answer to the Commission's complaint, in violation of 68 IAC 13-1-4.
8. On December 17, 2010, pursuant to IC 4-21.5-3-24(a)(1), Commission staff made a Motion for Issuance of Proposed Order of Default Judgment due to Respondent's failure to file an answer.
9. On December 27, 2010, a Proposed Order of Default Judgment was served on all parties by the ALJ.
10. On January 13, 2011, pursuant to IC 4-21.5-3-24, the ALJ issued an Order Granting Default Judgment because Respondent failed to file a written motion requesting that the Proposed Order of Default Judgment not be imposed and stating the grounds relied upon within seven (7) days of being served with the Proposed Order of Default Judgment.


11. Under IC 4-32.2-8-1(a)(1)(A) and 68 IAC 21-6, the Commission may suspend or revoke the license of or levy a civil penalty against a qualified organization for a violation of a provision of IC 4-32.2 or a rule of the Commission.

COMMISSION ACTION

Having considered the foregoing, the Commission hereby **APPROVES** the Order Granting Default Judgment of the Administrative Law Judge and **REVOKES** the Crisis Center, Inc.'s Annual Bingo License #121373.
