Supplemental funding was provided through the CARES Act to Indiana for the Low-Income Home Energy Assistance Program (LIHEAP) to prevent, prepare for, or respond to the coronavirus. LIHEAP provides assistance for home energy costs and is funded by the federal Department of Health and Human Services. IHCDA administers the program for Indiana. IHCDA was awarded \$16,991,924.00 in funding. Using Delegated Authority, \$16,482,168.00 was allocated to the organizations listed below.
