

# State of Indiana Department of Transportation Request for Information (RFI) Bat Species Identification RFI# 1907

### I. Purpose of Request for Information (RFI)

This RFI is being issued by the Indiana Department of Transportation (INDOT) to solicit essential information for potential professional services providers to identify bats to the species level from a composite or pooled guano sample.

# II. Background

INDOT must occasionally determine whether ESA listed bat species are roosting un bridges or buildings affected by our capital improvement projects. Identification from genetic material in guano is useful when visual identification is impractical (e.g. very tall structures) or impossible (bats are not currently present). We are interested in identifying regional potential contractors who could perform this work. The methods reference is:

### III. Presentation of Information

INDOT would like interested parties to submit a short technical brief (five page maximum) addressing:

- A. Can you perform the species identification method generally outlined in Walker et al. (2016) to 90% or better accuracy?
- B. What is your sample collection protocol and will a collection kit be provided?
- C. How will sample identity be maintained through storage, analysis, and reporting?
- D. What is the turnaround time for providing results?
- E. What is the average time to process from receipt of sample to report?
- F. What happens if a sample is inconclusive?
- G. How many samples could you process on a regular basis? What is the minimum number of samples you would need to process a year to provide the service?
- H. How will the lab monitor trends in accuracy of species identification?
- I. Who will be responsible for resolving problems?
- J. The State of Indiana has certain types of billing and payment procedures INDOT must adhere to? What are your billing and payment procedures?
