INTRODUCTION TO THE INDOT PUBLIC INVOLVEMENT MANUAL

The Indiana Department of Transportation (INDOT) has prepared the **INDOT Public Involvement Procedures Manual** to provide guidance to those who are engaged in providing public involvement opportunities related to INDOT decisions and actions and to let the public know what they can expect in terms of INDOT public involvement policies and practices.

This *Manual* is primarily addressed to INDOT staff and their consultants who will carry out INDOT's public involvement activities. This document will also be useful to Metropolitan Planning Organizations (MPOs), Regional/Rural Planning Organizations (RPOs) and local officials that conduct their own public involvement activities. The document will help the MPOs, RPOs and local officials understand where their processes fit with INDOT public involvement approaches and will provide them with ideas on how to implement their own public involvement programs. In addition, the document is intended to provide the interested public reader with information about INDOT's commitment to public involvement and about how and where the public can become involved in the planning and project development processes.

INDOT 2012 Public Involvement Procedures Manual Includes:

- Enhanced language regarding INDOT Planning & Programming including STIP development
- Requiring additional formal public involvement action for projects of lower environmental impact, thus completing a public feedback loop and adding a layer of customer responsiveness
- Document preparation developed through significant coordination with FHWA
- Coordination with INDOT Business Units contributing to, and participating in, the review process for the development of these procedures
- A documented process for disseminating the procedures document for public review and comment via statewide legal advertisement in 28 widely circulated newspapers (statewide) for a period of 45 days; INDOT used its Public Involvement List Serve and webpage to engage the public
- INDOT received 9 letters during public comment period; each letter was formally responded to in writing with copies attached for review
- Thorough explanation of public involvement under Section 106 of the National Historic Preservation Act
- Procedures do exceed minimum requirements for public involvement in transportation decision making
- Enhanced guidance regarding public involvement for Local Public Agencies
- Proactive engagement of several key stakeholder groups including INDOT Long Range Planning, STIP development, District Offices, Environmental Services, MPOs, RPOs, the consultant community and FHWA

INDOT Public Involvement Policies and Procedures lays out INDOT's fundamental requirements for public involvement, established by Federal and State law and regulations and by INDOT policies. The Policies and Procedures have been approved by the Federal Highway Administration (FHWA) on 3/16/2013

INDOT will review the public involvement *Policies and Procedures* as required by 23 CFR 450.212(a)(7). FHWA must approve any changes to these *Policies and Procedures*.
