**RE:** Emergency Amendment to the TIP

INDOT has requested emergency approval of the attached amendments to the TIP. INDOT projects in Bartholomew County must be included in both the INDOT STIP and the CAMPO TIP in order to advance to construction. A delay in the approval of these amendments could impair implementation of the projects. Voting on this amendment will be via email. Please respond to me with your vote by Friday, October 6.

CAMPO's bylaws allow approval of the proposed amendments through an emergency amendment process. This request meets the criteria as it has the potential to cause harm to the public, and because there is insufficient time to organize a Policy Board meeting. The section of the bylaws that allows an emergency amendment is shown below.

#### 5.3 Emergency Amendments

In some cases, a project is not in the TIP, or is not in the TIP correctly and the correction meets the Amendment criteria in section 5.1, thus, the project cannot move forward without an Amendment to the TIP. Further, (1) the public will be harmed by delaying the project because of safety, fiscal prudence road condition, or other public disbenefits, and (2) a Policy Board meeting is not soon, or cannot be immediately organized.

**Procedure:** A memo describing the project and reasons for its urgency and corresponding Resolution will be distributed to the CAMPO Policy Board members via email. Member must respond with a vote. No response is considered an abstention. The Amendment must pass by the majority of the membership and the Resolution signed before it can be implemented into the TIP. These memos and corresponding document changes will be provided to the public at the next Policy Board meeting.
