



# Indiana Conservation Hall of Fame Nomination Form

## Purpose

To recognize individuals who have made extraordinary contributions to the conservation and preservation of Indiana's natural and cultural heritage.

## Presentation

Each ICHOF winner will be honored at the Hall of Fame Induction Ceremony, profiled in *Outdoor Indiana* magazine, and will receive the distinctive ICHOF Award.

## Nominations

The ICHOF awards recognize individuals, living or deceased, who have made an extraordinary contribution to the conservation and preservation of Indiana's natural and cultural heritage.

The nomination form must be filled out completely, including a brief narrative of 250 words or less and bibliography.

Each nomination will be judged on its own merits. The descriptive narrative and any attached documentation must be presented in a clear and concise manner. The quality of the materials is more important than quantity. Nominations must be submitted by March 1 for consideration in the same year. Nominations are kept for consideration in future years. All decisions by the committee are final.

## Narrative

Include or answer the following:

- Brief life history
  - Is the nominee's contribution statewide, inter-state or of national significance?
  - What motivates the nominee's contribution?
  - What natural or cultural resources were affected by the contribution?
  - What areas of conservation have been influenced by the nominee's actions?
    - Education
    - Research
    - Land Acquisition
    - Historic and Cultural
    - Legislation, Policy formation or Public Leadership
    - Literature or Art
    - Habitat Restoration or Protection
    - Resource Management
  - A bibliography of sources to confirm information in the narrative is required.
- Nominations without documentation will not be considered for the Hall of Fame.
