The purpose of this filing is to make multiple changes to the Company's Concurrence and Exceptions and to the Check Sheets to indicate that the Company does not concur with entire sections or with portions of certain sections of the JSI interstate Tariff F.C.C. No. 1. as detailed below. These services are interstateonly services that are not applicable on an intrastate basis.

- 1. Concurrence & Exceptions Page 2: The Company does not concur with the entire Section 8 Digital Subscriber Line Services (DSL). CCI provides DSL on a detariffed basis as allowed by F.C.C.'s Wireline Broadband Order FCC 05-150, Released September 23, 2005 under ¶90. The word "Yes" under the Concur column for this section was changed to "No" and the word "None" under the CCI Exceptions column was replaced with "Not Applicable to Intrastate". The correction to the Concurrence and Exceptions for DSL will match Check Sheet Page CS 19.
- 2. <u>Concurrence & Exceptions Page 2</u>: Since there is some language in the **Table of Contents, General** Information/User Guidelines, Section 2 General Regulations, and Section 5 Access Ordering that applies to interstate-only services; the Company is adding a footnote to indicate that any information in these aforementioned sections are not applicable on an intrastate basis. Additional Interstate-only services besides DSL mentioned in bullet point 1 above and DSL Line Port include: Access Recovery Charge, Consumer Broadband-Only Loop, End-User Access Service, Federal Universal Service Charge, ISDN Line Ports, Internet Protocol Gateway Access Service, Local Number Portability, resubscription, Special Federal Government Access Services, and Stand-Alone Broadband Network Transport.

- 3. Concurrence & Exceptions Page 2: The name of Section 3 is being revised to match the name in the JSI interstate access tariff. The name changed from "Common Carrier Line (or CCL) Access Service & Federal Universal Service Charge (or FUSC)" to "Federal Universal Service Charge, ISDN Line Ports, DSL Line Port, and Consumer Broadband-Only Charge". The Company does not concur with any of the services listed in this section. Also see bullet point 6 below.
- 4. Concurrence & Exceptions Page 3: The Company is adding 2 comments to the CCI Exceptions column for Section 13 Additional Engineering, Additional Labor and Miscellaneous Services. Subsection 13.4 Presubscription is not applicable on an intrastate basis and is being added to the list of exceptions. The correction will match Check Sheet 20. In addition, the sub-sections for Access Recovery Charge (ARC) and Local Number Portability were added. All three sub-sections were streamlined and bulleted to make it easier to read.
- 5. Concurrence & Exceptions Page 3: The Company is adding 2 comments to the CCI Exceptions column for Section 16 Public Packet Data Network. Sub-Section 16.8 for Stand-Alone Broadband Network Transport (SABNT) and sub-Section 16.9 Internet Gateway Protocol Access Service are not applicable on an intrastate basis. Therefore, the word "None" under the CCI Exception column was changed to list these 2 sub-Sections and not applicable to Intrastate. Both subsections were bulleted to make it easier to read. Also see bullet points 9 & 10 below.
- 6. <u>Check Sheet Pages 1 and 2</u> are being revised to indicate which check sheets are being updated.
- Check Sheet Page CS 8 is being revised to change the name of Section 3 to match the name of Section 3 in the JSI interstate access tariff. Also see bullet point 3 above.
- 8. <u>Check Sheet Page CS 20</u> is being revised to add the word "of" to Section 11 name to match the name in the Company's Concurrence and Exceptions Page 2.
- Check Sheet Pages CS 29 & 30 are being revised to indicate and remove the tariff sheets for sub-Section 16.8 Stand-Alone Broadband Network Transport (SABNT) that are not applicable on an intrastate basis. Also see bullet point 5 above.
- 10. <u>Check Sheet Page CS 30</u> is being revised to indicate and remove the tariff sheets for sub-**Section 16.9 Internet Gateway Protocol Access Service** that are not applicable on an intrastate basis. Also see bullet point 5 above.
