**Requests:** (1) To permit customers to use credit cards, or other forms of electronic fund

payment related to utility bills issued by Indiana Utilities; (2) to change the information to be obtained from customers; (3) to change customer requirements related to shut off valves; and (4) to change requirements related to customers

maintaining access for Indiana Utilities to customer premises.

**Customer Impact:** (1) Customers will be able to pay their bills with a credit card or other form of

electronic payment. Processing fees may apply.

(2) A valid state driver's license or federally issued identification card may be required before Indiana Utilities is obligated to render gas service. Where the property to be served is anticipated to be leased to third parties, Indiana Utilities may require copies of the lease agreement reflecting the name of the tenant and contact information for such tenant for purposes of contact by Indiana Utilities where access to the premises and equipment may be required or other notification to the third party by Indiana Utilities is necessary.

(3) Inside customer piping and equipment must include appropriate shut off valves for gas using equipment, and shall be maintained by the customer in a good

working condition.

(4) All customers and all third party lessors of the premises shall advise Indiana Utilities of their intent to make changes to the premises that would limit Indiana Utilities's access to the premises. Any relocation of any Indiana Utilities's equipment due to the customer or lessor's changes in the premises shall be made by Indiana Utilities but charged to the customer on the next monthly billing by

Indiana Utilities.
