MR. SPEAKER:

I move that House Bill 1001 be amended to read as follows:

- 1 Page 139, between lines 18 and 19, begin a new paragraph and
- 2 insert:
- 3 "SECTION 96. [EFFECTIVE JULY 1, 2011] (a) As used in this
- 4 SECTION, "fund" refers to the Indiana state teachers' retirement
- 5 fund established by IC 5-10.4-2-1.
- 6 (b) Not later than October 1, 2011, the fund shall pay the
- 7 amount determined under subsection (c) to a member of the fund
- 8 (or to a survivor or beneficiary of a member) who retired or was
- 9 disabled before January 1, 2011, and who is entitled to receive a
- 10 monthly benefit on July 1, 2011. The amount is not an increase in
- 11 the pension portion of the monthly benefit.
- 12 (c) The amount paid under this SECTION to a member of the
- 13 fund (or to a survivor or beneficiary of a member) who meets the
- 14 requirements of subsection (b) is determined as follows:
- 15

5 (e) This SECTION expires January 1, 2012.

6 SECTION 97. [EFFECTIVE JULY 1, 2011] (a) As used in this
 7 SECTION, "fund" refers to the public employees' retirement fund
 8 established by IC 5-10.3-2-1.

9 (b) Not later than October 1, 2011, the fund shall pay the
 10 amount determined under subsection (c) to a member of the fund
 11 (or to a survivor or beneficiary of a member) who retired or was
 12 disabled before January 1, 2011, and who is entitled to receive a
 13 monthly benefit on July 1, 2011. The amount is not an increase in
 14 the pension portion of the monthly benefit.

15 (c) The amount paid under this SECTION to a member of the
 16 fund (or to a survivor or beneficiary of a member) who meets the
 17 requirements of subsection (b) is determined as follows:

 31 amount paid under this SECTION.

32 (e) This SECTION expires January 1, 2012.

33 SECTION 98. [EFFECTIVE JULY 1, 2011] (a) As used in this
 34 SECTION, "trustee" has the meaning set forth in IC 10-12-1-10.

35 (b) As used in this SECTION, "trust fund" has the meaning set
 36 forth in IC 10-12-1-11.

37 (c) Not later than October 1, 2011, the trustee shall pay from the
 38 trust fund to each employee beneficiary of the state police 1987
 39 benefit system covered by IC 10-12-4 who:

- 40 (1) retired or was disabled after June 30, 1987, and before
- 41 July 2, 2010; and
- 42 (2) is entitled to receive a monthly benefit as of September 1,
- 43 2011;

44 an amount equal to one percent (1%) of the maximum basic annual
 45 pension amount payable to a retired state police employee in the
 46 grade of trooper who has completed twenty-five (25) years of
 47 service as of July 1, 2011, as calculated under IC 10-12-4-7.

1 **(d) The amount paid under this SECTION is not an increase in**
 2 **the monthly pension amount of an employee beneficiary.**

3 **(e) This SECTION expires January 1, 2012.**

4 SECTION 99. [EFFECTIVE UPON PASSAGE] **(a) As used in this**
 5 **SECTION, "participant" has the meaning set forth in**
 6 **IC 5-10-5.5-1.**

7 **(b) As used in this SECTION, "plan" refers to the state excise**
 8 **police, gaming agent, gaming control officer, and conservation**
 9 **enforcement officers' retirement plan established by IC 5-10-5.5-2.**

10 **(c) Not later than October 1, 2011, the board of trustees of the**
 11 **public employees' retirement fund shall pay the amount**
 12 **determined under subsection (d) to a plan participant (or to a**
 13 **survivor or beneficiary of a plan participant) who retired or was**
 14 **disabled on or before January 1, 2011, and who is entitled to**
 15 **receive a monthly benefit on July 1, 2011. The amount is not an**
 16 **increase in the annual retirement allowance.**

17 **(d) The amount paid under this SECTION to a plan participant**
 18 **(or to a survivor or beneficiary of a plan participant) who meets**
 19 **the requirements of subsection (c) is determined as follows:**

20 If a Plan Participant's Creditable	20 The Amount Is:
21 Service Is:	
22 Less than ten (10) years	22 \$125
23 (only in the case of a plan participant	
24 receiving disability retirement benefits)	
25 At least ten (10) years,	
26 but less than twenty (20) years	26 \$235
27 At least twenty (20) years,	
28 but less than thirty (30) years	28 \$325
29 At least thirty (30) years	29 \$400

30 **(e) The creditable service used to determine the amount paid to**
 31 **a plan participant (or a survivor or beneficiary of a plan**
 32 **participant) under this SECTION is the creditable service that was**
 33 **used to compute the plan participant's retirement allowance under**
 34 **IC 5-10-5.5-10 and IC 5-10-5.5-12, except that partial years of**
 35 **creditable service may not be used to determine the amount paid**
 36 **under this SECTION.**

- 1 **(f) This SECTION expires January 1, 2012."**
- 2 Renumber all SECTIONS consecutively.
