Temporarily adds rules concerning instant game number 522. Effective April 27, 2001.
SECTION 1. The name of this instant game is "Instant Game Number 522, Happy Father's Day".
SECTION 2. Instant tickets in instant game number 522 shall sell for one dollar (\$1) per ticket.
SECTION 3. (a) Each instant ticket in instant game number 522 shall contain nine (9) play symbols and play symbol captions in the game play data area all concealed under a large spot of latex material. One (1) play symbol and play symbol caption shall appear in the area labeled "BIG FISH". Eight (8) play symbols and play symbol captions shall appear in the area labeled "YOUR FISH" and be arranged in pairs representing numbers and prize amounts.
(b) The play symbols and play symbol captions in instant game number 522, other than those representing prize amounts, shall consist of the following possible play symbols and play symbol captions:

(c) The play symbols and play symbol captions representing prize amounts in instant game number 522 shall consist of the following possible play symbols and play symbol captions:

SECTION 4. The holder of a ticket in instant game number 522 shall remove the latex material covering the nine (9) play symbols and play symbol captions. If one (1) or more of the "YOUR FISH" numbers match the "BIG FISH" number, the holder is entitled to the prize amount paired with the matched number. A player may win up to four (4) times on a ticket. The matched play symbols, prize amounts, and number of winners in instant game number 522 are as follows:

SECTION 5. (a) There shall be approximately two million (2,000,000) instant tickets initially available in instant game number 522.
(b) The odds of winning a prize in instant game number 522 are approximately 1 in 4.80.
(c) All reorders of tickets for instant game number 522 shall have the same:
(1) prize structure;
(2) number of prizes per prize pool of two hundred forty thousand $(\mathbf{2 4 0 , 0 0 0})$; and
(3) odds;
as contained in the initial order.
SECTION 6. The last day to claim a prize in instant game number 522 is November 30, 2001.
SECTION 7. SECTIONS 1 through 6 of this document expire December 31, 2001.
