TITLE 65 STATE LOTTERY COMMISSION

DIGEST

Temporarily adds rules concerning instant game number 523. Effective April 27, 2001.

SECTION 1. The name of this instant game is "Instant Game Number 523, Blast of Cash".

SECTION 2. Instant tickets in instant game number 523 shall sell for five dollars (\$5) per ticket.

SECTION 3. (a) Each instant ticket in instant game number 523 shall contain eleven (23) [sic.] play symbols and play symbol captions in the game play data area all concealed under a large spot of latex material. Three (3) play symbols and play symbol captions shall appear in the area labeled "WINNING NUMBERS". Twenty (20) play symbols and play symbol captions shall appear in the area labeled "YOUR NUMBERS" and be arranged in pairs representing numbers or pictures and prize amounts.

(b) The play symbols and play symbol captions in instant game number 523, other than those representing prize amounts, shall consist of the following possible play symbols and play symbol captions:

(c) The play symbols and play symbol captions representing prize amounts in instant game number 523 shall consist of the following possible play symbols and play symbol captions:

SECTION 4. The holder of a ticket in instant game number 523 shall remove the latex material covering the twenty-three (23) play symbols and play symbol captions. If one (1) or more of "YOUR NUMBERS" match any of the "LUCKY NUMBERS", the holder is entitled to the prize amount paired with the matched number. If the play symbol of a picture of a money bag with the play symbol caption "WIN" is exposed in the "YOUR NUMBERS" area, the player is automatically entitled to the paired prize amount. A player may win up to ten (10) times on a ticket. The matched play symbols, prize amounts, and number of winners in instant game number 523 are as follows:

SECTION 5. (a) There shall be approximately two million (2,000,000) instant tickets initially available in instant game number 523.

- (b) The odds of winning a prize in instant game number 523 are approximately 1 in 3.06.
- (c) All reorders of tickets for instant game number 523 shall have the same:
- (1) prize structure;
- (2) number of prizes per prize pool of one hundred twenty thousand (120,000); and
- (3) odds;

as contained in the initial order.

SECTION 6. The last day to claim a prize in instant game number 523 is May 31, 2002.

SECTION 7. SECTIONS 1 through 6 of this document expire June 30, 2002.
