DIGEST

Temporarily adds rules concerning instant game number 525. Effective April 27, 2001.
SECTION 1. The name of this instant game is "Instant Game Number 525, Play To Win".
SECTION 2. Instant tickets in instant game number 525 shall sell for one dollar (\$1) per ticket.
SECTION 3. Each instant ticket in instant game number 525 shall contain nine (9) play symbols and play symbol captions in the game play data area all concealed under a large spot of latex material. The play symbols and play symbol captions in instant game number 525 shall consist of the following possible play symbols and play symbol captions:
(1) $\$ 1.00$

ONE
(2) $\$ 2.00$

TWO
(3) $\$ 3.00$

THREE
(4) $\$ 5.00$

FIVE
(5) $\$ 10.00$

TEN
(6) $\$ 15.00$

FIFTEEN
(7) $\$ 35.00$

TRY FIVE
(8) $\$ 100$

ONE HUN
(9) $\$ 300$

THR HUN
(10) $\$ 1,000$

ONE THOU

SECTION 4. The holder of a ticket in instant game number 525 shall remove the latex material covering the nine (9) play symbols and play symbol captions. If three (3) matching play symbols and play symbol captions are exposed, the holder is entitled to a prize of the matched amount. The prize amounts and number of winners in instant game number 525 are as follows:

SECTION 5. (a) There shall be approximately three million four hundred thousand $(\mathbf{3}, \mathbf{4 0 0}, 000)$ instant tickets initially available in instant game number 525.
(b) The odds of winning a prize in instant game number 525 are approximately $\mathbf{1}$ in $\mathbf{3 . 9 4}$.
(c) All reorders of tickets for instant game number 525 shall have the same:
(1) prize structure;
(2) number of prizes per prize pool of two hundred forty thousand $(\mathbf{2 4 0 , 0 0 0})$; and (3) odds;
as contained in the initial order.
SECTION 6. The last day to claim a prize in instant game number 525 is April 30, 2002.
SECTION 7. SECTIONS 1 through 6 of this document expire May 31, 2002.
