- 2. 18 new markers, possibly one orphan marker, two revised markers.

- 1. Recent Dedications
  - a) Senate Avenue YMCA (Marion Co.), dedicated October 20.
  - b) Jasper Sherman Bilby (Ripley Co.), dedicated November 5.
  - c) Chapman Harris (Jefferson Co.), dedicated November 18.

#### 2. Remaining Dedications

- a) Union Literary Institute (Randolph Co.), marker is installed. As of yet, not dedication has been scheduled.
- b) Bill Garrett/Integrating Basketball (Monroe Co.), marker will be dedicated next spring after the conclusion of the college basketball season.
