Eligibility:

The "You Are Here" Teen Video Challenge for Indiana is open only to legal U.S. residents who are residents of the state of Indiana aged 13-18. Participants are ineligible if directly related to the panel of judges for the contest. By participating, entrants agree to be bound by these Contest Rules. Each participant or group may submit one video per entry. Each entry must include signed model release form(s). All submission must be received by **Monday, February 28, 2011**. Late entries will not be accepted. A DVD of the video will be requested from all winners.

Terms and Conditions:

All music (that is not supplied by CSLP or in the public domain) and all artwork (other than public domain) must be created by the entrant. CSLP (and all CSLP member affiliates) have permission to use the "You are Here" submitted teen video including all work created and all intellectual property embodied therein as per the Model Release form.

How to Enter:

1. **Go to** <http://cslpreads.org> and click the "You Are Here" Teen Video Challenge 2011
2. **Explore** the resource link for art and music ideas in the public domain.
3. **Download** the optional audio files, "You Are Here"
4. **Create** your video
5. **Entitle** your video with: You Are Here-IN-Your First Initial & Last Name (same as on Entry Form)
Example: You Are Here - IN - J.Doe
6. **Upload** your video to YouTube.com
7. **Fill out** Model Release form and Entry form.

Video Criteria for Acceptance:

All videos must:


- Be 30 to 90 seconds.
- Use the CSLP 2011 teen slogan "You Are Here" to convey the idea of teens as a part of a diverse country and world where all are unique and important.
- Promote the idea of using public libraries to learn about ourselves and the wonderful world.
- Promote the fun of reading.
- Entitle your video: "You Are Here-your 2-letter State abbreviation-Your First Initial & Last Name" (same as Entry Form) *example: You Are Here-CA-J. Smith*
- May include "You Are Here" audio in English, Spanish and/or Instrumental.

Video will be judged on the following criteria:

- Creativity
- Message clarity and relevance
- Motivation and inspiration
- Overall impact

Prizes:

April 2011, CSLP will award each CSLP approved State Teen Video Challenge Winner \$250. Their Public library or member affiliate will receive \$100 from CSLP.

Model Release Form for Publication and Video Purposes or the "You Are Here" Teen Video Challenge 2010

This release is a binding contract between the undersigned and Collaborative Summer Library Program ("CSLP"). It insures to the benefit of and binds both parties' heirs, successors, representatives and assigns.

Each member of a team that submits a video or, who appears in the video, must sign a release.

Subject of Release. "Material" refers to all video, images, photographs, mixed media, music, text and other forms of copyrighted material that I supply to CSLP.

License. I grant CSLP an irrevocable, perpetual, world-wide, royalty-free, sub-licensable, transferable, non-exclusive license to use, reproduce, distribute, publish, prepare derivative works, display, perform, and otherwise exploit the Material in any media form.

Name and Likeness. I grant CSLP an irrevocable, perpetual, world-wide, royalty-free license to use my name and likeness, image, voice in the Material as well as my biographical information for advertising, publicity, trade or any other lawful purpose.

No 3rd Party Copyrighted Material. I agree that the Material I submit does not include any copyrighted material belonging to someone else unless it is in the public domain.

No Obligation to Use and No Right to Review. I understand that CSLP is under no obligation to use the Material. I understand that I do not have a right to inspect and approve the finished product or such written or spoken copy used in connection with the finished product.

Consideration. I understand and agree that the sole consideration offered by CSLP is the evaluation of the Material for its potential use, and acknowledge the receipt and adequacy of this consideration.

Indemnity. I agree to indemnify and hold harmless CSLP, its officers, directors, employees and agents from any actual or alleged claims that arise from the licensed use of this Material including without limitation any claim of infringement, defamation or any breach of my representations or warranties.
