Eastern Bartholomew Water Rate Case: Consumer Comments Invited, May 18 Hearing Scheduled in Taylorsville

Customers of Eastern Bartholomew Water Corporation have two opportunities to comment on the utility's pending rate request.

The Indiana Office of Utility Consumer Counselor (OUCC) continues to invite written comments for the case record. In addition, the Indiana Utility Regulatory Commission (IURC) will hold a public field hearing on Thursday, May 18, 2017 in Taylorsville.

The IURC's May 18 hearing will start at 7:00 p.m. in the cafeteria at Taylorsville Elementary School (9711 Walnut St.).

- Consumers will be able to speak directly to the Commission, under oath and on the record, regarding the rate case.
- Consumers will also be able to submit written comments for the case record.
- Comments will carry equal weight whether they are oral or written.
- Commissioners are not allowed to answer questions during the field hearing. However, OUCC staff will be available before, during and after the hearing to address questions about the process.

Written comments the OUCC receives by June 14, 2017 will be filed with the Commission to be included in the case's formal evidentiary record. Current base rates for Eastern Bartholomew Water Corporation – a not-for-profit utility serving more than 5,100 customers in Bartholomew, Decatur, and Jennings Counties – were approved in 2008. The utility's pending request would raise the monthly residential water rate for 5,000 gallons from \$22.83 to \$33.77.

Testimony and exhibits filed by the utility cite increases in operating and maintenance costs while proposing a number of capital improvements. Specific projects include a new water treatment plant, a new storage tank, new office and maintenance buildings, main extensions, new meters and hydrants, and GIS mapping of the utility's water distribution system.

The OUCC – the state agency representing consumer interests in cases before the IURC – is reviewing the utility's request and anticipates filing testimony on May 23, 2017.
