A. LSA Document #09-796

Re: Amendments to 839 IAC 1-2-5

A. Reinstatement for Licenses Expired for Three-Plus Years

1. Debra A. Cannon, License # 35000551A

The Board reviewed documentation from Ms. Cannon regarding her request to renew her expired license to practice marriage and family therapy. Ms. Cannon's license has been expired since April 1, 2000. Ms. Cannon submitted documentation of having completed 40 hours of CEUs within the previous 24 months, which is necessary for the renewal of licenses expired for longer than three (3) years. Further, Ms. Cannon submitted a letter detailing the reasons for failing to renew her license.

A motion was made and seconded to require Ms. Cannon to personally appear before the Board to discuss her professional history since allowing her license to expire.
