IV. PERSONAL APPEARANCE

1. Colleen Merkel – ACEC – Continuing Education Developments

ACEC is a trade association for Engr. & Arch. Firms. There are 3500 - 4000 of registered PEs associated with ACEC Indiana. There are 5500 people who are employed with the associated firms. ACEC is seeking guidance for pertinent information that should be included in their continuing ethics education. These would include items that are relevant to the board. ACEC is looking for recommendations. Vince discussed the recent rule update and modern technologies (such as implications of driverless cars) as just a few things he mentioned. Vince offered to assist ACEC with continuing education and ethical issues that have been arising nationally. Opal mentioned the national topics going on with licensure; computer-based testing, fewer people taking the FE exam, trying to encourage students to take the exam since it is a requirement for licensure. ISPE has the Indiana Professional Engineer Journal (IPEJ) that comes out six times a year. Every issue of the IPEJ includes a Registration Board News article which covers things that are concerned with the Board. The Board now has a newsletter two times a year which includes a link to the IPEJ. Mike Fink provides a quiz with each issue about Indiana Statutes and Rules in IPEJ. Steve Gillman provided some real-life examples about stamping, employee pilferage, CE related issues, and drunk driving. The whole point of the Board is to protect the health, safety and welfare of the general public. They also discussed electronic continuing education. ACEC wants to distribute the Board newsletter as well. The board gave approval for ACEC to share the Board newsletter with their mailing list.
