**PETITION FOR SUMMARY SUSPENSION**

The Office of the Indiana Attorney General, by counsel, Deputy Attorney General Morgan L. Burton, on behalf of the State of Indiana (“Petitioner”), moves the Indiana State Board of Pharmacy (“Board”) to suspend the Temporary Psychologist permit of David Edward Mowry, Psy.D., (“Respondent”) for 90 days and in support of its petition states the following:

1. Respondent is a Temporary Psychologist Permit holder in the State of Indiana holding license number 99040814A since January 13, 2010.
2. This Board has jurisdiction to suspend Respondent’s license in accordance with the provisions of Ind. Code § 4-21.5-4 et seq. and Ind. Code § 25-1-9-10.
3. Respondent’s address on file with the Board is 1877 Gaynell Dr., Seymour, IN 47274.

4. On or about July 12, 2009, Respondent submitted an application for Licensure to Practice Psychology in Indiana to the Board. On this application, he stated that he attended the Walden University School of Psychology (“Walden”) in Minneapolis, Minnesota and submitted transcripts to that effect.
5. On or about January 13, 2010, the Board issued a Temporary Psychology Permit to the Respondent based on his application.

6. On or about March 10, 2010, Jeanette Roberts, Director of the Board, received information that the Respondent has never attended Walden and therefore has not obtained the proper education to practice psychology. Ms. Roberts also obtained information that the Respondent submitted paperwork to his employer, Behavioral Care Solutions, indicating that he was a "Counseling Psychologist" using license number 20040556A, which belongs to an expired, but licensed Psychologist in the State of Indiana.


7. Due to the above facts, the Respondent represents a clear and immediate danger to the public health and safety if allowed to continue to practice as a Psychologist in the State of Indiana as he does not possess the requisite information and has falsified his credentials to his employer.

**WHEREFORE**, the State of Indiana requests that this Board set a hearing on this petition for summary suspension and suspend Respondent's nursing license for a period of ninety (90) days and for all other proper relief.
