STATE BUDGET COMMITTEE MEETING MINUTES January 9, 2003

The business meeting was held at 2:00 P.M. on January 9, 2003 at the State House, House Ways and Means Committee Room in Indianapolis. Seven (7) action items and one (1) review item were considered. Senator Simpson called the meeting to order. Representative Buell made the motion to consider the agenda; Representative Espich seconded the motion. The motion passed with five ayes. Director Schultz made a motion for item 3 to transfer \$100,000 from the Center of Excellence in Education Maintenance to Residential Programs & Services Reserves; Representative Cochran seconded the motion. The motion passed with five ayes. Representative Espich made a motion to amend the agenda to add item 7, the renovation of the locking system in a state prison; Senator Meeks seconded the motion. The motion passed with five ayes. After discussion of the agenda, Representative Cochran made a motion to approve the agenda as amended; Senator Meeks seconded the motion. The motion passed with five ayes.

Action Items:

1. <u>Indiana University- Southeast (750)</u> IUS Library and Student Center Project No. A-9-00-1-30

Indiana University seeks approval to proceed with the Library and Student Center project on the New Albany Campus. The project would construct a new 75,000 GSF library and renovate 108,000 GSF of the Student Center. The library will cost \$15,000,000 and the Student Center renovation would cost \$6,000,000. This project shall not be eligible for fee replacement appropriations until FY 2006. Approval of this project by the State Budget Committee does not constitute a commitment to future funding for plant expansion.

- 2. <u>Indiana University Purdue University Indianapolis (750)</u> \$1,250,000
 Emerson Hall Dept of Surgery 2nd Floor Renovation IUPUI
 Project No. A-2-03-2-18
 Indiana University seeks approval to renovate approximately 8,610 GSF on the second floor of Emerson Hall on the IUPUI campus. The renovation will create more efficient space, add space, and update dated and damaged finishes, including lighting and fire protection. The project is funded through gift funds.
 Funding: School of Medicine Gift Funds \$1,250,000
 Estimated plant expansion request: \$0
 CHE review: 12/13/02
- Indiana University (750) \$1,250,000
 Substation C Replacement and Relocation Bloomington Project No. A-1-03-2-25
 Indiana University seeks approval to proceed with the replacement and relocation of Substation C on the Bloomington campus. Substation C provides 5kV and 12.4kV high voltage service to twenty student residential buildings and academic structures. The project will be funded through reserves. Funding: Residential Programs & Services Reserves \$1,250,000
 CHE review: 1/7/03
- 4. <u>Indiana University Purdue University Fort Wayne (760)</u> \$28,000,000 New Construction Student Housing – Fort Wayne Project No. B-3-03-1-16 Purdue University eachs approved to proceed with the construction of seven stude

Purdue University seeks approval to proceed with the construction of seven student housing buildings containing a total of 568 beds in 220 apartments. The building will be located east of campus on land owned by the university. The total cost of the project is \$28M to be funded with Acts of 1927 bonding authority (I.C. 21-12-8). In addition, gift funds of \$3M will be used. The project is not eligible for fee replacement or plant expansion.

Heine Pharmacy Renovation Phases III and IV – West Lafayette Project No. B-1-03-2-18 Purdue seeks approval to proceed with the renovation of the Heine Pharmacy on the West Lafayette campus. The renovation will house NIH-funded research in Medicinal Chemistry and Molecular Pharmacology. Existing spaces will be gutted and new research laboratories, faculty and student offices and analytical labs will be constructed. The project will be funded through grant funds and reserves. Purdue is not seeking plant expansion for this project. Funding: NIH Grant \$1,975,425 Reserve for Renewals \$1,975,425
