| | Generator Repair Project | |

The Department of Correction requests approval for a repair on a generator at the Westville Correctional Facility. The generator has experienced an internal electrical failure allowing the overproduction of power and melting of essential components. This project includes a complete overhaul of the failed generator and a temporary generator for the repair period.

2. Indiana Veterans' Home (570) \$5,757,998
 MacArthur Hall Renovation

The Indiana Veterans' Home (IVH) has been advised from the Federal Veterans Administration that grant funds are available for the renovation of MacArthur Hall. Funding for the grant is to be allocated between the State of Indiana (35%) and the Federal Government (65%). This grant will be used to complete a full renovation of the three patient care floors at MacArthur Hall (built in 1982) along with installation of an Electronic Medical Records (EMR) system, new telephone system, resident call light system, and roam monitoring system at a total cost of \$5,757,998. Architectural and engineering design fees were approved in a prior Budget Committee meeting on June 4, 2012.
