BANK ACCOUNT RECONCILIATIONS

The Township Court converted their financial system to Odyssey during 2009. Once the Court converted to the new financial system a new bank account was opened and the Court started using the new bank account for daily transactions. The old bank accounts were not closed out and still maintain a cash balance.

For the current working bank account, during the examination period, court personnel compared the receipts and disbursements shown in Odyssey to deposits and checks cleared by the bank on a monthly basis. However, reconcilements between the fund balance and bank account balance were not performed. During the course of the examination, multiple Odyssey reports were used to determine if the fund balance reconciled to the bank balance as of December 31, 2010. As of December 31, 2010, we identified cash short in the amount of \$749.18; in the working bank account; however, there could have been several other reconciling items that we could not identify based on the reports that were provided.

Additionally, as of December 31, 2010, the old bank accounts remain open with a cash balance; however, an accurate reconcilement was not provided for this bank account either. An initial review of the reconcilement identified cash long in these accounts in the amount of \$32,366; however, a detailed review of the list of outstanding checks provided, which totaled \$80,192, revealed that many of the checks on the outstanding checklist were not verifiable to the records provided. We have identified similar issues with this reconcilement in previous reports, most recently Report B35727.

Indiana Code 5-13-6-1(e) states: "All local investment officers shall reconcile at least monthly the balance of public funds, as disclosed by the records of the local officers, with the balance statements provided by the respective depositories."
