RE: Approval of Governing Body Reorganization – Carmel Clay School Corporation

MEMORANDUM

Recommendation: approve governing body reorganization.

Pursuant to IC 20-23-8-10(a)(2), the Carmel Clay School Corporation (the "Corporation"), by its School Board of Trustees on December 12, 2016, adopted a resolution to initiate a plan to change the composition of its governing body. Subsequent to the Corporation adopting the resolution to reorganize its governing body, the Corporation submitted the attached materials for the State Board of Education's ("Board") review and consideration. The materials include the prior governing body plan, the resolution adopted by the Corporation and the minutes from the Corporation's meeting during which the resolution was adopted, the publication information that includes the language of the amended provisions of the governing body plan, and the county clerk's certification that no protest petitions or alternative plans were submitted to the clerk's office. The governing body resolution seeks to amend the following provisions:

• Redefining of the Boundaries of the Residence Districts

New Residential Map included for review

After review of the materials provided by the Corporation, it is evident that 1) the governing body resolution was properly approved by the Corporation, 2) the resolution was properly published in a local newspaper, and 3) that no protest petitions or alternative plans were submitted to the clerk's office. Furthermore, the new governing plan satisfies the requirements of I.C. 20-23-8, IC 20-23-4-27, IC 20-23-4-29.1, and IC 3-8-1-34. As such, the new governing body plan is recommended for approval by the Board pursuant to IC 20-23-8-15.

RESOLUTION INITIATING A CHANGE IN THE PLAN OF ORGANIZATION FOR THE BOARD OF SCHOOL TRUSTEES OF THE CARMEL CLAY SCHOOLS OF HAMILTON COUNTY, INDIANA

RESOLVED, by the Board of School Trustees ("Board") of the Carmel Clay Schools, Hamilton County, Indiana ("School Corporation") that the manner in which the Board is constituted shall be changed under I.C. 20-23-8-10 so that it is constituted in accordance with the following plan ("Plan"):

- Name. The governing body of the School Corporation shall be called the Board of School Trustees as it presently is.
- 2. Members to be Elected Number, Term and Qualification. The Board shall consist of five (5) members who shall be elected at the general election in even-numbered years ("general election"), in accordance with I.C. 20-23-4-29.1 by all the registered voters voting at each applicable school board election in the School Corporation. Each member shall serve for a term of four years and may succeed himself or herself in office. Each member of the Board shall, as of the time of his or her election, be registered and entitled to vote for members of the Board of the School Corporation and meet all other statutory requirements to serve on the Board.
- 3. Manner of Election. Three members of the Board shall be selected from residence districts, one member for each residence district and two members of the Board shall be selected at large. The residence districts shall be called Carmel Clay 1, Carmel Clay 2 and Carmel Clay 3 and shall be configured as shown on the map attached to this resolution. In addition, the residence districts


may be described by reference to streets or other geographical features and these descriptions shall be deemed incorporated into this resolution but the map shall control any discrepancy between the map and the description. The time of election shall be staggered so that the three (3) members from residence districts will be elected at one general election and two (2) at large members at the next succeeding general election. All registered voters shall be entitled to vote on each board member, whether from a residence district or at-large.

- 4. <u>Time Plan Effective</u>. The Plan shall be effective as provided in IC 20-23-8.
- 5. <u>Transition Provisions</u>. The Board at the time this Plan is adopted is elected as specified in this plan and the only change in that plan is the redefining of the boundaries of the residence districts as set forth in this plan. Therefore, there is no need for transition provisions.

NOTICE OF CHANGE IN BOARD PLAN

Notice is hereby given by the Board of School Trustees of the Carmel Clay Schools, Hamilton County, Indiana ("School Corporation") that it has initiated a change in the manner in which it is constituted by adopting a plan in accordance with IC 20-23-8-10.

The text of the plan is as follows:

1. Name. The governing body of the School Corporation shall be called

the Board of School Trustees as it presently is.

2. Members to be Elected - Number, Term and Qualification. The Board shall consist of five (5) members who shall be elected at the general election in even-numbered years ("general election"), in accordance with I.C. 20-23-4-29.1 by all the registered voters voting at each applicable school board election in the School Corporation. Each member shall serve for a term of four years and may succeed himself or herself in office. Each member of the Board shall, as of the time of his or her election, be registered and entitled to vote for members of the Board of the School Corporation and meet all other statutory requirements to serve on the Board.

3. Manner of Election. Three members of the Board shall be selected from residence districts, one member for each residence district and two members of the Board shall be selected at large. The residence districts shall be called Carmel Clay 1, Carmel Clay 2 and Carmel Clay 3 and shall be configured as shown on the map attached to this resolution. In addition, the residence districts may be described by reference to streets or other geographical features and these descriptions shall be deemed incorporated into this resolution but the map shall control any discrepancy between the map and the description. The description of the districts is as follows:

Carmel Clayy 1: Starting at the intersection of Ditch Road and 146th Street, then south on Ditch Road to Main Street, then east on Main Street to River Road, then south on River Road to White River, then generally east along the course of the Vestal Ditch to the White River, then generally north along the White River to 146th Street, then west along 146th Street to Ditch Road, the point

of beginning.

Carmel Clay 2: Starting at the intersection of 146th Street and the western boundary line of Clay Township, then east along 146th Street to Ditch Road, then south along Ditch Road to Main Street, then east along Main Street to River Road, then generally east along the course of the Vestal Ditch to White River, then generally south along the course of the White River to 116th Street, then west along 116th Street to Ditch Road, then north along the west boundary line of

Clay Township to 146th Street, the point of beginning.

Carmel Clay 3: Starting at the intersection of 116th Street and the western boundary line of Clay Township, then south along the western boundary line of Clay Township, then south along the western boundary line to 96th Street, then east along 96th Street to the White River, then generally north along the course of the White River to 116th Street, then west along 116th Street

to the western boundary line of Clay Township, the point of beginning.

The time of election shall be staggered so that the three (3) members from residence districts will be elected at one general election and two (2) at large members at the next succeeding general election. All registered voters shall be entitled to vote on each board member, whether from a residence district or

4. Time Plan Effective. The Plan shall be effective as provided in IC 20-23-8.

5. Transition Provisions. The Board at the time this Plan is adopted is elected as specified in this plan and the only change in that plan is the redefining of the boundaries of the residence districts as set forth in this plan. Therefore, there is no need for transition provisions.

Not later than one hundred twenty (120) days after date of the publication of this notice, the voters of the school corporation may file with the Clerk of the Hamilton County Circuit Court a petition protesting the foregoing plan or a petition submitting an alternative plan.

The petition protesting the plan shall be signed by at least 20% of the voters of the School Corporation or 500 voters, whichever is less. A petition submitting an alternative plan shall be signed by at least 20% of the voters of the School Corporation. Any petition thus filed shall be certified by the Clerk and be filed with the School Corporation's governing body, its Board of School Trustees, in accordance with IC 20-23-8-14.
